SYNOPSIS

Students conduct an independent research study using library resources, and prepare a critical review and study proposal on a topic approved by a faculty supervisor. A written report and an oral presentation of the work are required before a grade can be assigned. Work equivalent to **at least eight hours per week** during the fall and winter terms is required. Prerequisite(s): fourth-year standing in the Food Science and Nutrition program and permission of the department.

LEARNING OUTCOME AND OBJECTIVES

This is the capstone course for the Food Science and Nutrition program. The learning outcome of this course is ***to conduct independent research that extends current knowledge in food science and nutrition.***

Through this course, students will:

- Carry out hypothesis-driven research
- Work independently
- Analyze data and perform statistical analysis
- Describe principles and mechanisms with appropriate depth
- Support arguments with primary scientific studies
- Provide systematic review of state of knowledge
