

Teaching Excellence Awards

Up to three awards may be given each year. Two awards are designated for full-time faculty members (Instructors, Lecturers, and Professors) at any rank and one award is designated for a contract instructor teaching in the Faculty. The awards are established to recognize overall excellence in teaching and/or teaching innovation.

Criteria for Award

Excellence in teaching and teaching innovation may be demonstrated by any of the following:

- consistency in teaching excellence over time and across courses at Carleton over the
 previous five years for full-time faculty members, and at least two years (and a minimum
 of three courses) for contract instructors.
- commitment to student advising and engagement.
- successful innovation in curriculum/program design or classroom instruction undertaken
 in the previous five years for full-time faculty members, and at least two years (and a
 minimum of three courses) for contract instructors. (The committee will look favorably on
 applications that demonstrate a willingness to engage in experimentation that has
 informed new approaches to instruction or curriculum design.)

Applications

Faculty and contract instructors must self-apply. Chairs/Directors and faculty colleagues are encouraged to approach the faculty member or contract instructor to express their support and to encourage their application. Only self-nominations will be considered.

Application Package

Applicants must provide:

- current curriculum vitae
- short statement (limit of three pages) that outlines the nature of the applicant's teaching excellence and/or innovation.
- optional letters of support from Chairs/Directors and faculty colleagues.
- selected student comments submitted as part of the student experience questionnaire
 process may be included where relevant, however, applicants are <u>not</u> encouraged to
 solicit letters from students. Instead, applicants may submit names of up to five (5)
 students to their Chair/Director who will confidentially solicit up to three letters of
 support.
- other relevant materials including teaching scores, course outlines, etc.

Award Recognition

The recipient of each award will receive a \$1,500 taxable cash award and an engraved award statuette. They will also be profiled by the Faculty to recognize their achievement.

Procedures and Selection Committee

Applications should be submitted via e-mail to Stephanie Bourk (stephanie.bourk@carleton.ca), Office of the Dean, Faculty of Public Affairs, by March 15, 2023. The selection committee for the Teaching Excellence Award is chaired by the Associate Dean, Academic. The award selection committee membership will normally consist of four FPA faculty members, all of whom have had their teaching achievement and/or innovation recognized through an FPA Teaching Excellence Award, or a University, provincial or national teaching award. The selection committee will make its recommendation to the Dean.

Past FPA Teaching Excellence Award Winners

Past winners are eligible to re-apply eight years after receipt of their last award.

Please note that since the Office of the Dean sponsors these awards, faculty and professional staff working in the Office of the Dean are not eligible for these awards nor are they able to provide nominations or letters of support for others.
