Clinical and Forensic Applications of the Hare Psychopathy Checklist-Revised (PCL-R)

The Hare Psychopathy Checklist-Revised (PCL-R) is widely accepted as the most reliable and valid method for assessing psychopathy. The PCL-R uses interview and collateral (e.g., file) information to score 20 items that measure the interpersonal, affective, and social deviance/lifestyle components of psychopathy. The PCL-R was designed to measure the construct of psychopathy, but because psychopathy is related to general, violent, and sexual reoffending, the PCL-R increasingly finds use in dangerous offender, sexual predator, and civil commitment proceedings and as an important factor in the assessment of risk in a variety of forensic populations. It also is used as an aid in the determination of sentencing options, treatment suitability, and institutional placements. The aims of the workshop are to (1) provide an overview of the uses and potential misuses of the PCL-R; and (2) provide participants with training and practice in the administration, scoring, and interpretation of the PCL-R.
