1. Description

Initiation aux méthodes et notions d'analyse littéraire, au moyen d'un survol historique de la littérature française, notamment les grands mouvements et l'évolution des genres (relation de voyage, poésie, théâtre, roman). Le cours s'articule autour d'un corpus d'œuvres diversifiées, dont l'organisation servira à mieux approfondir les notions théoriques ciblées.

2. Objectifs

Ce cours d'introduction permettra aux étudiant(e)s d'acquérir des connaissances élémentaires dans la littérature française (mouvements et écoles, genres, œuvres marquantes), de s'initier aux pratiques et discours de l'analyse littéraire (typologie du texte littéraire, concepts et enjeux de l'analyse de texte) et, enfin, de développer une réflexion *critique* sur le texte littéraire. Parallèlement à ces trois objectifs, lectures et travaux participeront à l'approfondissement des compétences langagières, tout particulièrement de l'expression écrite dans un cadre universitaire.

- Travail noté 1 (10%) : 7 octobre
- Travail noté 2 (15%) : 2 novembre
- Un travail écrit (30%) : 30 novembre

9. Plagiarism

The University Senate defines plagiarism as “*presenting, whether intentionally or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.” Plagiarism is a serious

offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.
