#### **DESCRIPTION DU COURS:**

Survol historique des littératures d'expression française au Québec et au Canada : principaux auteurs, grands mouvements, évolution des genres. Initiation aux méthodes et notions d'analyse littéraire.

Dans ce cours, nous étudierons un roman, des contes, une pièce de théâtre, des nouvelles, des poèmes/chansons. Ces textes nous permettront de discuter de certaines notions littéraires afin de pouvoir analyser les œuvres et elles nous donneront aussi un aperçu de l'histoire littéraire et sociale du Canada français.

#### **OBJECTIFS DU COURS 2203**

- Lire des textes qui appartiennent à différents genres et époques littéraires.
- Identifier quelques traits caractéristiques de ces différents genres littéraires.
- Connaître quelques auteurs et œuvres du Canada français.
- Développer quelques notions d'analyse littéraire.
- Développer des connaissances de la culture et de l'histoire du Canada français.
- Améliorer les compétences langagières à l'oral et à l'écrit

- FREN 2203 et la langue orale. La qualité de l'expression orale (prononciation, intonation, grammaire, vocabulaire, aisance) fera l'objet d'une évaluation. Je vous encourage fortement à tirer profit du service de soutien oral et des activités à l'oral proposés par le département pour pratiquer (voir le site du département).

Penalties are not trivial. They can include a final grade of "F" for the course.

#### PANDEMIC MEASURES
