Sample Careers - Environmental Studies

Agricultural Inspector – a public sector job; involves ensuring businesses comply with federal and provincial laws and regulations that govern health, quality and safety.

Environmental Consultant – a private sector job; involves working on commercial or government contracts to assess and address a variety of environmental issues for clients.

Environmental Lobbyist – a non-profit sector job; involves advocating for public policy that serves the interests of environmental non-profits through awareness campaigns and negotiation with elected officials.
