Who May Use This Guide

- Current Carleton students who have a valid study permit.
- Recent Carleton graduates who have applied successfully for a Post-Graduation Work Permit.

Most people who are not Canadians need either a Temporary Resident Visa (TRV, also called a visitor visa) or an Electronic Travel Authorization (eTA) to travel to Canada. [Learn which document you need](#) at the Immigration, Refugees, and Citizenship Canada (IRCC) website.

If you have a TRV that will expire or has expired while you are studying or working in Canada, you can apply for a new one using the information in this guide. It's important to know:

- Your study permit or your work permit is your Canadian status document. You should always apply for a new permit **before** your current permit expires, otherwise you may lose your temporary resident status and have to leave Canada. You don't lose your status in Canada if your TRV expires. However, it is a good idea to have a valid TRV at all times, in case you must travel outside of Canada. You won't be able to return from most countries to Canada without it, even if your study permit or work permit is valid.
- Foreign nationals residing in Canada who hold either a study permit or a work permit are eligible to apply for a TRV within Canada. This guide assumes applicants are applying in Canada for the TRV. Applying from outside of Canada is a similar process, but is not covered in this guide.
- Often a TRV expires on the same date as the holder's study or work permit. Applying for new documents while residing in Canada is a two-step process:
 1. Apply for a new study permit or work permit, which is mailed to a Canadian address.
 2. Apply for a new visa after IRCC approves the study or work permit application.

If you have travel plans, you may need to account for the [processing times](#) of both these applications. **If you leave Canada with only a valid study permit or work permit, you will have to apply for a new visa from outside of Canada before you can return.** Your permit does not authorize travel to Canada.

- Your TRV may reference your status in Canada with S-1, SW-1, W-1 or V-1 coding. However, your visa remains valid to its expiry date even if your status in Canada changes. All valid TRVs authorize travel to Canada. Every foreign national requesting entry to Canada must declare the purpose of their visit each time.
- As a temporary measure that was begun in 2022 and continues until further notice, IRCC is processing V-1 coded visas for some students and work permit holders in Canada with expiry dates matching passport expiry dates instead of the study permit or work permit expiry date. [This is not an error and you do not have to contact IRCC](#) if you receive a V-1 visa.
- Immigration medical exams (IMEs) are normally valid for one year only, but IRCC has a temporary policy in place until October 2029. In-Canada applicants who would normally require an IME may be exempt from completing a new exam if they had a clear IME within the past five years. Find details on the [IRCC website](#).
- You may see references to a Temporary Resident Permit or TRP at the IRCC website or in application materials. Despite the similar name, this is a different document and a very different application from a TRV.

1. Apply Online for a TRV

If you have a valid study permit or work permit, you may apply for a new TRV from within Canada.

If you are planning to travel, you should check IRCC’s [current processing times](#). In addition to the time needed for IRCC to process the application, you should allow an additional 2-3 weeks to submit your passport to IRCC by courier for insertion of the visa before you leave Canada.

Step One: Get Your Documents Ready

The application is made online in your [IRCC Secure Account](#). (The IRCC Portal is for visa applications made from outside of Canada.)

If you recently renewed your study permit, the TRV application process and required documents will be similar. You may be able to use some of the same documents; but they should be updated if they are more than a few months old.

All documents must be submitted as PDF or photo files.

(a) Students need these supporting documents to apply for a TRV

- **Valid Passport** — include all pages that have your personal information, valid visas, and entry and exit stamps.
- **Valid study permit**, or the IRCC notice that your study permit application has been approved.
- **Proof of next term's enrolment** — In most cases, you can use a current [Certificate of Enrolment](#). If you are nearing the end of the term identified in the Certificate or if it's the summer term and you can't yet register for the upcoming Fall term, you should include a second Carleton document that shows expected program completion date:
 - [For undergraduates] A *Statement of Student Progress* from the Registrar's Office that states when you will complete your program, based on the credits you still need to earn. Contact the ISSO first for a referral note. Co-op students may use a *Confirmation of Student Enrollment Letter* from mySuccess that states their expected program completion date.
 - [For graduates] A letter from your department or the FGPA stating your expected program completion date.

Administrative fees for Carleton documents: There is no charge for a Certificate of Enrolment. A \$20 + HST non-refundable fee may apply to requests for documents showing program completion dates. See Carleton [Miscellaneous Administrative Charges](#).

- **Carleton transcript** — Order an [unofficial transcript](#) from Carleton Central.
- **Proof of PAL exception** — Complete this template letter and upload it as proof of the exception.

Dear Immigration Officer,

I am applying for a temporary resident visa, with purpose of travel "returning student", so that I may complete my ongoing studies in [program name] at Carleton University.

According to information on the [IRCC website](#), I am exempted from the requirement for a Provincial Attestation Letter. Specifically, my situation is this:

- I have entered Canada, and I am applying to study at the same DLI and level of study as my current study permit.

I trust that the Carleton documentation and the study permit I have provided with this application verify my claim for the exception. I hope you will contact me if you require further information to process my application.

- **Proof of financial means to study** — You need bank statements or other proof that you have enough money for one year of tuition and living expenses, or until you finish your studies, whichever comes first. Please see the [GO-ISSO's resources for renewing your study permit](#).
- **Photo** — Like a passport photo. Check the specifications in the application information.

(b) PGWP holders need these supporting documents to apply for a TRV

- **Passport** — include all pages that have your personal information, valid visas, and entry and exit stamps.
- **Work Permit** — or IRCC approval notice that includes the work permit document number.
- **Photo** — Like a passport photo. Check the specifications in the application information.

Step Two: Sign in and set up an online application

1. [Begin an online application](#) at the Government of Canada website, IRCC Secure Account log-in. Use your Canadian bank sign-in information *or* a GC Key (Government of Canada account).
2. Scroll past the references to a Personal Reference Code to look for “Start an Application, then “Apply to Come to Canada”. Choose the option “Visitor visa, study or work permit”.
3. Answer the eligibility questionnaire. See Section Two for tips.

After you complete the questionnaire, the system will create your document list. Once you start an application, you have 60 days to finish it. Your work is automatically saved each time you sign-out or otherwise take a break from working on the application.

Step Three: Complete application form IMM 5257

You may see a reference to IMM 5257 as an *Application for a Temporary Resident Visa from Outside of Canada*, but this is not an error. The same form is used by applicants who are inside of Canada.

1. Download IMM 5257 (the PDF application form) from the document list to your computer.
 - Open the file with [Adobe Acrobat Reader](#).
 - Fill in the information on your computer. See Section Three: *Answers to Selected Questions on Application Form IMM 5257*.
2. When the form is complete, click the “Validate” button, then save the document on your computer.
3. Upload the validated form to your application list.

Step Four: Upload your documents to your application.

Each upload button accepts only one document. You may have to merge two or more documents before you upload them. [SmallPDF](#) is a website that can help you to merge multiple PDFs and compress them if the file size is too large to upload. On a Mac computer, you can drag and drop Preview thumbnail images to combine PDFs.

Two application items are identified as optional:

- Schedule 1 IMM 5257. If you answer “No” to background questions #3-6 on IMM 5257, you don’t need this form.
- Client Information. This is a line to upload a letter of explanation and any additional documents. This isn’t usually needed for a TRV application for a study or work permit holder who is already in Canada.

Step Five: Pay the fee and submit your application

When all your documents are uploaded, continue to sign the application electronically, pay the \$100 fee with a debit or credit card, and submit the application.

Step Six: Watch your email for messages from IRCC

Sometimes immigration officers ask you to provide additional documents. You must reply to them promptly or your application will probably be refused. When the officer requests a new document, a line is added to your online application for you to upload it. In addition to uploading the document, it’s very important to click on “next”, or else the document will not be submitted to IRCC.

You will be notified by email when a decision is made, and a new message will appear in your account. This message includes instructions for submitting your passport to IRCC.

Step Seven: Submit your passport

You will send your passport to the IRCC office in Ottawa so the visa can be inserted. It’s not possible to do this in person.

Buy two Xpresspost envelopes from Canada Post: one to send the passport to IRCC and another addressed to yourself so they can return it to you. [Xpresspost](#) is an expedited courier service. You will receive a tracking number for each of your two envelopes. Full instructions for submitting your passport will be in your approval letter and are also on the [IRCC website](#).

If you apply in Canada and then must leave Canada before you get your new visa, it is possible to submit your passport to a visa office overseas after you are notified of approval of your application. Contact a [Visa Application Centre](#) for details.

2. Tips for Answering the Eligibility Questionnaire

Online applications begin with a questionnaire. Your answers tell the system which forms and documents to include in your application list.

This is the simplest version of the questionnaire for a TRV. Depending on your answers to some questions (for example, questions about family members or questions related to a medical exam), you may see additional questions.

(a) Questionnaire Answers for Students

Q. What would you like to do in Canada?

A. Study

Q. How long are you planning to stay in Canada?

A. Temporarily – more than 6 months

Q. Select the Code the matches the one on your passport

A. [Pick the country from the pull-down menu]

Q. What is your current country of residence?

A. Canada

Q. Do you have a family member who is a Canadian citizen or permanent resident and is 18 years or older?

A. [Yes or No]

Q. What is your date of birth? – day, month, year

A. [This date should match what is on your passport.]

Q. Which of these responses describes your situation?

A. Pick one answer from pull-down:

I am a doctoral student in the USA applying to a DLI to pursue a doctoral degree

I am a student residing in Canada and am changing DLIs

None of the above

[This question allows IRCC to identify some study permit applications for priority processing. Carleton students renewing their permits will pick “none of the above”.]

Q. Do you have a provincial or territorial attestation letter or meet an exception from submitting a provincial or territorial attestation letter?

A. Yes, I meet an exception from submitting a provincial or territorial attestation letter

Q. Are you a lawful permanent resident of the United States with a valid U.S. Citizenship and Immigration services (USCIS) number?

A. [Yes or No]

Q. *What is your current immigration status in Canada?*

A. Student

Q. *What is your current marital status?*

A. [Choose from the pull-down menu]

Q. *What is your province of destination?*

A. Ontario

At this point, you will see two options:

- Study Permit (in Canada)
- Temporary Resident Visa

Click “Continue” beside Temporary Resident Visa.

Q. *Which of the following best describes your situation?*

A. I have a study permit (*If your study permit says Institution: Designated Learning Institution*)

OR I have a study permit for a specific institution (*If your study permit names Carleton University*)

Q. *Have you had a medical exam performed by an IRCC authorized panel physician (doctor) within the last 12 months?*

A. [Yes or No] If your answer is Yes, you don’t need to do a new medical exam. You will need your E-medical receipt or the reference number.

Q. *A medical exam is needed before you submit your application for foreign nationals who:*

- *Want to stay in Canada for more than 6 months and have live in one or more designated countries or territories for more than six months in the past year or;*
- *Intend to work in one of the following jobs:*
 - *Health sciences worker*
 - *Clinical laboratory worker*
 - *Patient attendant in nursing or geriatric homes*
 - *Medical student admitted to Canada to attend university*
 - *Medical elective and physician on short term assignment*
 - *Teacher of primary or secondary schools or other teachers of small children*
 - *Domestics worker, someone one gives in-home care to children, the elderly and the disabled*
 - *Day nursery worker*

Do you fit into one of these categories?

Q. *Are you the spouse, common-law partner or dependent child of a person who: holds a work permit or is applying for a work permit, etc.?*

A. [Yes or No]

Q. *Are you the spouse, common-law partner or dependent child of a person who is: a foreign government officer in Canada on an exchange agreement, etc.?*

A. [Yes or No]

Q. *Are you the spouse, common-law partner of an accredited diplomat, etc.?*

A. [Yes or No]

Q. *Have you been told by an IRCC office that you are approved in principle for permanent residence in Canada?*

A. [Yes or No]

Q. *Have you submitted a permanent resident application in Canada?*

A. [Yes or No]

Q. *Do you have a written job offer?*

A. [Yes or No]

Q. *Does this situation apply to you? You have an employer-specific work permit, etc.*

A. No

Q. *What is your current marital status?*

A. [Choose from the pull-down menu]

Q. What is your province of destination?

A. Ontario

At this point, you will see the option to apply for a Temporary Resident Visa. Depending on the answers you selected, it's possible you may find you are eligible for another kind of work permit as well. Click "Continue" beside Temporary Resident Visa.

Q. Which of the following best describes your situation?

A. I have an open work permit.

Q. Have you had a medical exam performed by an IRCC authorized panel physician (doctor) within the last 12 months?

A. [Yes or No] If your answer is Yes, you don't need to do a new medical exam. You will need your E-medical receipt or the reference number.

Page One

UCI = Unique Client Identifier

This is your identity number with IRCC. You can find it on your study permit or work permit. Your UCI remains the same for your lifetime, even if your passport number, name, or other personal information changes.

(a) Students

- *Status – Student*
- *From: (Date of start of studies, according to first study permit) to (Expiry date of current Study Permit)*

(b) PGWP Holders

Page Two

National Identity Document

Not all countries have a National ID. If country of nationality does issue this document, provide the information.

Contact Information

- Mailing address in Canada — This should be somewhere where mail addressed to you will be safe. It doesn't have to be the same as the place you live.
- Residential address — This is where you are living now.

Page Three – Students

Purpose of my visit

Pick "Returning Student" from the pull-down menu.

Indicate how long you plan to stay

Funds available for my stay

You can use the same figures you used for a recent study permit application, or whatever amount reasonably represents your expenses for the length of time indicated in the previous question. You will have to provide bank statements or other proof that you have this much money available.

You do not have to provide proof of financial resources for this application. However, you should put something reasonable in answer to this question. Options might be: your current bank balance, or, if you are working, 6 months salary.

Name, address and relationship of any person(s) or Institution(s) I will visit

If you are employed, enter your employer information. If not, enter your personal information.

Have you had any post-secondary education?

Enter information about your studies at Carleton, assuming this is your highest level of post-secondary studies to date.

Employment

Your current activity/occupation can be your current job or if unemployed, "job seeker". If the latter, enter "none" for the employer name.

Page Four — Background Information

Answer Yes or No to questions about:

- Your exposure to tuberculosis
- Any physical or mental disorder, if you might use services in Canada
- Your immigration history, especially in Canada
- Your criminal history
- Your history in the police or the military
- Your exposure to war crimes.

Most students answer "No" to most of these questions, but please read them carefully. Answering incorrectly is misrepresentation, which can make you inadmissible to Canada. Note that all applicants must answer "Yes" to part (c) of Question #2:

(c) Have you previously applied to enter or remain in Canada?

Yes. Enter brief information about your previous applications to come to Canada as a visitor, student or worker. The type of application and the month and year are usually sufficient.

Page Five — Signature and Declaration

Do you consent to be contacted by IRCC or an organization at IRCC's request, in the future?

Check Yes or No. If you answer Yes, you may get an email in the future from IRCC asking you to answer a survey.

I consent to the release to IRCC and Canada Border Services Agency of all records and information for the purposes of processing my request...

I declare that I have answered all questions in this application fully and truthfully.

This is a mandatory declaration.

Type in your name and the date, indicating that you agree to these statements. You don't need to sign the form with a pen. You will sign the application electronically after you pay the application fee.
