Course Overview

This course is a broad introduction to the history, society, and culture of the ancient Greeks. This course also functions as an introduction to ways of studying and thinking about the classical world, that is, to the discipline of Classics. The period covered ranges from the Greek Bronze Age to Greeks in the Roman world, although much of our attention will be on Classical Athens. We will be working with a textbook, but we will also be examining at first hand a range of primary sources: texts, artworks, and artefacts produced by the Greeks themselves.

Deferred Final Exams

The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
