CLCV 1002 A is an introduction to the study of Greek antiquity from the Mino-Mycenaean Age (c. 3000-1100 BC) down to the mid-second century BC, when Greece became a Roman protectorate (146 BC).<sup>1</sup> The culture and society of Greece will be set in historical context through lectures and studied through readings, through translations from representative ancient authors, and through art and architecture. After the Bronze Age our concentration will be on Athens in particular.

Course work will require the writing of two non-cumulative tests (multiple choice, fill-in-the-blank, key terms, map component, and possibly slide identifications) worth 2 x 30 = 60% and a cumulative final examination (of similar format to the tests) worth 40%. The final will be scheduled by the Registrar's Office and written during the exam period following the end of classes in December; for the dates of the tests see below:<sup>2</sup>

<sup>1</sup> Alternatively BCE is used for BC by some writers, CE for AD. As for the whole business of dating: The chronology for Bronze Age Greece in particular is constantly being adjusted; therefore, I will follow the dates of Amos and Lang (below) at times but sometimes suggest other dates. This in no way is meant, however, to detract from the text as a whole.

<sup>2</sup> Should you be absent from either test, you are responsible for contacting your T.A. to arrange for a make-up, which will be given one week to the day after the test missed and during the normal class time. *A medical excuse will be required.* You are also responsible for acquiring the class notes for the lecture material missed while writing the make-up; you should, therefore, ask one of your fellow students to take notes.

### COPIES OF WRITTEN WORK SUBMITTED

Always retain for yourself a copy of all essays, term papers, written assignments or take-home tests submitted in your courses.

### PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
