#### CLCV 1002 B: SURVEY OF GREEK CIVILIZATION

Winter 2022

asynchronous online course through Brightspace

This course provides an introduction to the study of Greek antiquity, the discipline of Classics and its methodologies. The culture and society will be set in historical context and studied through readings from representative ancient authors (in translation) and through the art and architecture of the period.

According to Carleton, **asynchronous format** refers to an online course in which "the instructor and students share information, ideas, and learning experiences in a virtual course space. Asynchronous courses do not have live, scheduled meetings online. However, students are expected to remain up to date with the deadlines and due dates provided by the instructor. These courses require high-speed Internet access and a computer."

"Office hours": you have several options to get your questions answered in this course.

- 1) Live "Question & Answer" via Big Blue Button (link in Brightspace) at 11 to 11:30am Wednesdays. Q&A sessions will be held most weeks through term, especially before requirements. They will be hosted by the professor or a Teaching Assistant. Type your question in "Chat" or turn on your audio (and video) to ask it. Although only 30 minutes are scheduled for Q&A each week, the prof remains until all questions are answered.
- 2) <u>Email the professor or a Teaching Assistant</u>. We check email daily and respond as soon as possible, normally in less than 24 hours. Please use your Carleton email address.
- 3) To speak privately with the professor, contact her via email to set up an appointment to meet on Zoom or by telephone.

## **Readings:**

Optional reading: if you wish to read an excellent introduction to Greek civilization, I highly recommend: David Sansone, Ancient Greek Civilization (3<sup>rd</sup> ed. Wiley-Blackwell 2017). This text is freely available in <u>full text online</u> through Carleton's MacOdrum library.

## Required readings: posted on Brightspace under "Required Readings"

All are "primary sources" (literature written by ancient Greeks) translated into English. Each can be read in a couple hours.

There are 11 readings in total: 3 plays (2 tragedies, 1 comedy), 1 philosophical dialogue, 2 excepts from ancient history, and 5 "books" (ie. chapters) from epic poetry. The readings are:

<u>Each requirement</u> covers only part of course content, includes some choice, and tests your knowledge of lecture content. Tests will consist of short answer and essay questions. Commentaries require you to write about specific passages taken from primary source readings. Instructions and an example commentary can be found on Brightspace under "Syllabus & Academic Requirements".

<u>e-proctoring</u>: All academic requirements for this course (test, commentary and final exam) will be written in a scheduled and timed online environment with the use of an e-proctoring system provided by Scheduling and Examination Services. <u>BONUS mark opportunities</u>: The bonus in this course will be <u>up to 4%</u> added to your final grade by successfully completing <u>one or both</u> of the following:

## 1) writing and submitting a practice commentary by February 18.

- Pick a passage (5-7 lines long) from any of the required readings for our course and follow the instructions for how to write a Commentary (posted on Brightspace). The practice commentary will be graded out of 4 and you will receive feedback <u>before</u> the required commentary is due.

## 2) completing 4 optional online quizzes throughout term.

- Earn up to 1% bonus per quiz. Each quiz consists of 10 multiple choice questions, so each correct answer will earn you 0.1 bonus marks. Quizzes will be available online <u>for 1 week</u> after each relevant section of the course. The date each quiz closes can be found in the schedule at the end of the syllabus and on Brightspace.

The final date for voluntary withdrawal without academic penalty is April 12, 2022.

# Academic Integrity Policy (updated June 2021)

**Plagiarism** is presenting, whether intentionally or not, the ideas, expression of ideas, or work of others as one's own.

Plagiarism includes reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source. Examples of sources from which the ideas, expressions of ideas or works of others may be drawn from include but are not limited to: books, articles, papers, literary compositions and phrases, performance compositions, chemical compounds, art works, laboratory reports, research results, calculations and the results of calculations, diagrams, constructions, computer reports, computer code/software, material on the internet and/or conversations.

## **Examples of plagiarism** include, but are not limited to:

- any submission prepared in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, paraphrased material, algorithms,

formulae, scientific or mathematical concepts, or ideas without appropriate acknowledgment in any academic assignment;

- using another's data or research findings without appropriate acknowledgement;
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one's own; and
- failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.

## Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

- 1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor and in all cases this must occur no later than three (3) working days after the term work was due. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
- 2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
- 3. If a student is concerned the instructor did not respond to the request for academic accommodation or did not provide reasonable accommodation, the student should consult with the department/school/institute chair/director. If a mutually agreeable accommodation to complete course requirements prior to the course grade submission deadline cannot be achieved, the Associate Dean will become involved. If academic accommodation is not granted, and the student receives word **after** the academic withdrawal deadline, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses) for a final grade of WDN (Withdrawn) in the course(s). If academic

- accommodation is not granted, and the student receives word **prior** to the academic withdrawal deadline, the student may elect to withdraw from the course(s).
- 4. Furthermore, if academic accommodation is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. ## **Deferred Final Exams**

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

- 1. be made in writing to the Registrar's Office no later than three working days after the original final examination or the due date of the take-home examination; and,
- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office here.

## Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in <u>Carleton Central</u> within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published <u>fee deadlines</u> and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published <u>deadlines</u> (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the "Calculate amount to pay" button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.
