Description

In this course we will investigate the Roman world from approximately the 6th century BCE through to the 6th century CE. Rather than focusing on historical narrative (i.e. the sequence of political or military events), we will approach the Roman civilization through social and cultural themes. Our data will be Rome's art, archaeology, and literature. First, we will have a brief review of the history of Rome in the Mediterranean in order to situate our class in time and space. Then, we will explore inter-related themes which are present throughout the Roman period (e.g. popular entertainment, the army, the role of women, slavery, religion and cult) and consider how they each changed over time. The class tends to alternate: focusing on artistic and technological production one week, and on social and cultural issues the next week.

The textbook for the course is:

The class lectures will complement information found in the textbook and on cuLearn. You should expect that in some cases the lectures will place emphasis on different subjects than the textbook might. Thus, attendance in class is strongly recommended. You will do better in the class if you have read the assigned textbook chapters.

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
