Course Description

The course will examine various works of the Greek and Roman epic genre. Students will read in full three foundational epics from the western literary tradition: the *Iliad* and *Odyssey* of Homer, and the *Aeneid* of Vergil. Throughout the course we will consider the historical and cultural context of the texts, and the importance of literary imitation in the evolution of the genre of epic. Themes examined throughout the course include the hero and the divine, life and death, love and hate, betrayal and revenge. This course has an intensive reading load.

Virgil *Aeneid*, translated by D. West

Deferred Term Work

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made. [More information.](#)

The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
