Course Description

We will be reading in their entirety the three major epic poems of Greek and Roman antiquity: Homer's *Iliad* and *Odyssey*, and the *Aeneid* of Vergil. Through lectures, writing assignments, and discussion participation, students will explore the nature of epic poetry and ancient literature more broadly, the mythological content, the themes and problems of the poems themselves, their place in historical and social context, and their afterlife in later history and literature.

Learning Outcomes

- Understanding of the conditions and nature of ancient epic.
- Firm grasp of the plot and action of Homeric poems and the *Aeneid*.
- Understanding of main scholarly and interpretive problems.
- Ability to articulate and make arguments about major themes and problems.

Important Notes

- There will be two multiple choice, knowledge-based (viz. not interpretive), open book quizzes. They will be online on Brightspace, and you will have the whole day (12:01 AM

to 11:59 PM) in which to take them. There will be around 20 questions each, in ~30 minutes (I will confirm this information).

- The first quiz will take place **Oct 12** (week 6)
- The second quiz will take place **Nov 23** (week 11)
- There are two more deadlines for writing assignments:
 - First, short response (~600 words) to an interpretive question. You will choose from a list of questions and answer one by closely reading a passage from the poems. This is an exercise in focused, close attention to a small part of a literary work, with the goal of making an argument that is clearly based on evidence.
 - Second, an essay of moderate length (~1,200 words). A list of prompts will be provided, or you may come up with a topic of your own. You will use the skills practised in the first assignment and apply them to more nuanced arguments in which you will need to consider multiple passages from the poems and the evidence can be contradictory.
- The deadlines for the writing assignments are as follows:
 - Part 1: **Oct 19**
 - Part 2: **Dec 9**
- There will be a forum on Brightspace where you can post any questions you might have. Before posting, please take a moment to see if the question has not already been answered, either in this syllabus or in previously posted questions. Students should also feel free to post replies or further discussions to any topic on this forum.

Exam notes

- There will be a multiple choice, knowledge-based, open book and open notes final during exam period. This is designed to encourage a strong grasp of the plot, and should not be challenging if you have followed all the materials through the semester.

Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the **instructor** concerned and for making alternate arrangements with the instructor and in all cases this must occur **no later than three (3) working days after the term work was due**. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
3. If a student is concerned the instructor did not respond to the request for academic accommodation or did not provide reasonable accommodation, the student should consult with the department/school/institute chair/director. If a mutually agreeable accommodation to complete course requirements prior to the course grade submission deadline cannot be achieved, the Associate Dean will become involved. If academic accommodation is not granted, and the student receives word **after** the academic withdrawal deadline, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses) for a final grade of WDN (Withdrawn) in the course(s). If academic accommodation is not granted, and the student receives word **prior** to the academic withdrawal deadline, the student may elect to withdraw from the course(s).
4. Furthermore, if academic accommodation is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

1. be made in writing to the Registrar's Office **no later than three working days after the original final examination or the due date of the take-home examination**; and,

2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in [Carleton Central](#) within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published [fee deadlines](#) and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published [deadlines](#) (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the "Calculate amount to pay" button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.

In addition, to help ease the stress and aid students' transition to university life, a new compassionate [First-Year Grading Policy](#) has come into effect, which will automatically convert all F grades in a student's first two terms to NR ("No Record") and allow students to convert any passing letter grade (up to 2.0 credits) to CR ("Credit"). Courses that receive an NR designation will not be included on a student transcript, and CR courses will not be factored into a student's CGPA.
