COURSE OBJECTIVES

Many modern scientific and technical disciplines are filled with vocabulary that is derived from classical Latin or Greek. Such words can often seem arcane and mysterious to outsider and insider alike. Yet, with a basic knowledge of classical languages, these terms often become transparent and illuminating. This course will enable students to decode this technical terminology by learning the basic principles of Greek and Latin word formation, as well as the base meanings of many important and commonly used terms.

Deferred Term Work

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made. More information.

The application for a deferral must:

- 1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination;
 and.
- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office forms and fees page.

Withdrawal From Courses

Withdrawn. No academic credit, no impact on the CGPA.
