asynchronous online course through Brightspace

The art, architecture, and archaeology of ancient Greece. Vase painting, sculpture, architecture, town planning and analogous arts.

Carleton defines "asynchronous format" as an online course in which "the instructor and students share information, ideas, and learning experiences in a virtual course space. Asynchronous courses do not have live, scheduled meetings online. However, students are expected to remain up to date with the deadlines and due dates provided by the instructor. These courses require high-speed Internet access and a computer."

<u>Virtual Office hours:</u> you have several options to get your questions answered.

- 1) Ask questions live via Big Blue Button (Brightspace) at 12 noon to 12:30pm Wednesdays. These Q&A sessions will be held most weeks through term, especially before requirements are due. Although only 30 minutes are scheduled, the prof will remain until all questions are answered. You can type your question in "Chat" or turn on your audio (and video) to speak to the professor. We have 2 Teaching Assistants for the course and the TAs will host some sessions.
- 2) <u>Email the professor</u> (at above address). Please use your Carleton email address. I check email daily and respond as soon as possible, normally in less than 24 hours. Questions of interest to all students will be posted as announcements on Brightspace.
- 3) <u>To speak individually with the professor</u>, email her to set up an appointment via Zoom or telephone.

with proper references and bibliography (as instructed for this course). Failure to do so is plagiarism and will receive a grade of zero.

Scheduled and timed Midterm and Exam: worth 60% of your final mark

Each test will cover half the material in course lectures (weeks 1-6 or weeks 7-13). Types of questions may include slide ID and short answer but definitely at least 1 essay. There will be some choice.

Test answers should be based on material from lectures and the textbook; they do <u>not</u> require additional research BUT if you base any of your response closely on <u>any source</u> beyond lectures, you must properly cite and document that source (as in the research project for this course). Failure to do so is <u>plagiarism</u> and will receive a grade of zero.

Research Project: worth 40% of your final mark

A list of <u>topics</u> is posted on Brightspace. It includes a brief description of each topic and the proper bibliographic citation of 1 recommended peer-reviewed secondary source (to begin your research). Sign up for a topic by emailing the professor by **Feb.11**. If you have not signed up by the deadline, your work will not be accepted or graded.

You can propose a different topic, but you must get it <u>approved by the professor long before</u> <u>Feb.11</u>. Any proposed topic must be: 1) focused, 2) controversial, and 3) about ancient Greek art, architecture or archaeology.

<u>Deadlines and late penalties</u>: all deadlines for the research project will be 11:59pm on the due date. A **late penalty** of minus 10% starts <u>immediately</u> after the deadline has passed and increases by minus 10% each additional day up to minus 50%. After 5 days, I do not accept or grade late work.

You can, of course, request an extension (with reason) <u>before the deadline</u> by emailing the professor. You should also indicate how long an extension you think you will need.

Academic Integrity Policy (updated June 2021)

Plagiarism is presenting, whether intentionally or not, the ideas, expression of ideas, or work of others as one's own.

Plagiarism includes reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source. - failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.

Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

- 1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor and in all cases this must occur no later than three (3) working days after the term work was due. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
- 2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
- 3. If a student is concerned the instructor did not respond to the request for academic accommodation or did not provide reasonable accommodation, the student should consult with the department/school/institute chair/director. If a mutually agreeable accommodation to complete course requirements prior to the course grade submission deadline cannot be achieved, the Associate Dean will become involved. If academic accommodation is not granted, and the student receives word **after** the academic withdrawal deadline, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses) for a final grade of WDN (Withdrawn) in the course(s). If academic

- accommodation is not granted, and the student receives word **prior** to the academic withdrawal deadline, the student may elect to withdraw from the course(s).
- 4. Furthermore, if academic accommodation is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

- 1. be made in writing to the Registrar's Office no later than three working days after the original final examination or the due date of the take-home examination; and,
- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office here.

Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in <u>Carleton Central</u> within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published <u>fee deadlines</u> and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published <u>deadlines</u> (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the "Calculate amount to pay" button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.
