This course will cover the history of ancient Greece from the earliest prehistory to the cusp of the classical period with the end of the Greek-Persian wars. Major topics include the Bronze Age civilisations of Minoan Crete and the Mycenaeans, the so-called "dark age," and the formation and nature of the archaic city-state. We will study a range of materials as well as methods of analysis and drawing conclusions from limited evidence, including art, material culture, architecture, and written sources.

Notes

- Regular attendance is essential. Regular attendance includes the assumption that you come prepared to class and be actively engaged during class. Readings are to be done before the class for which they are assigned.
- The midterms will be in class and consist of two parts. The first part is multiple choice. The second part will require a written responses of around one side of writing (~400 words).
- The research assignment will consist of two parts. The first is a bibliographical exercise. The second will ask you to write up an overview of scholarship based on your bibliography. We will discuss this further in class.

• The final will be a scheduled online exam, and will be like the midterms in structure. It will be cumulative.

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. - 1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination;

- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office forms and fees page.
