#### Course Overview

This course follows on from CLCV | HIST 2902, History of Ancient Greece I, although the prior course is not a prerequisite. The course will begin with the defeat of the early 5th century Persian invasions, through the Athenian imperial democracy and the Peloponnesian War, to the 4th century and the rise of Macedon and Alexander. In addition, we will look at the social and political history of the period, the Greek historians and other sources for our understanding, as well as examine contexts for all of the above. We will be using a textbook for basic overview, but also reading extensively in ancient writers both for their historical accounts and to understand how the Greeks saw their own history.

### **Learning Outcomes**

- Understanding of the outlines of ancient Greek history, focusing on the 5th and 4th centuries.
- Understanding of the nature and history of classical Greek political and civic institutions, in particular, those of the Athenian democracy.
- Understanding of the relations between economics, social organisation, culture, and politics of the period.
- Ability to consider and evaluate scholarly arguments in relation to primary source material, and to use textual evidence to respond to specific positions.
- Ability to recognise and describe implicit attitudes and assumptions in primary source material by combining historical knowledge and close reading.

#### Notes

- The exams will be **online** and consist of multiple choice questions and written responses. The midterms consist of two parts. The first part is multiple choice. The second part will require a written response of at least ~500 words. The prompts for these written responses will be provided to you at least a week in advance so there will not be any time pressure for writing them. The second midterm will not cover material already tested in the first midterm. The final will be during exam period, but will otherwise follow the same format as the midterms. Content for the exams and quizzes will be drawn from both lectures and readings.
  - o The first midterm will take place **Feb 8** (week 5)
  - o The second midterm will take place **Mar 13** (week 9)
- The final will be a scheduled online exam, and will be similar to the midterms in structure. *The final will be cumulative, unlike the midterms.*
- Assigned readings should be completed before the class for which it was assigned.
  Students should come to class prepared for discussion. Students are expected to attend all lectures. Students are responsible for all missed work, regardless of the reason for absence. It is also the absentee's responsibility to obtain all missing notes or materials.
- For the writing assignment, you will be analysing one scholarly article from a selection that will be provided to you, breaking down what it argues, describing how it uses evidence and reasoning, and responding to its argument. A detailed description will be provided. This will be due toward the end of the semester, at the beginning of the last full week:

## Deferred TermWork

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

- 1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the **instructor** concerned and for making alternate arrangements with the instructor and in all cases this must occur **no later than three (3) working days after the term work was due.** The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
- 2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
- 3. If a student is concerned the instructor did not respond to the request for academic accommodation or did not provide reasonable accommodation, the student should consult with the department/school/institute chair/director. If a mutually agreeable accommodation to complete course requirements prior to the course grade submission deadline cannot be achieved, the Associate Dean will become involved. If academic accommodation is not granted, and the student receives word after the academic withdrawal deadline, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses) for a final grade of WDN (Withdrawn) in the course(s). If academic accommodation is not granted, and the student receives word prior to the academic withdrawal deadline, the student may elect to withdraw from the course(s).
- 4. Furthermore, if academic accommodation is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. ## **Deferred Final Exams**

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

- 1. be made in writing to the Registrar's Office no later than three working days after the original final examination or the due date of the take-home examination; and,
- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. ## Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in <u>Carleton Central</u> within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published <u>fee deadlines</u> and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published <u>deadlines</u> (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the "Calculate amount to pay" button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.
