Course description: This course will study the development and expansion of the Roman state from its inception to the end of the Republic and the accession of the first emperor. While there will be some discussion of social institutions, economy and culture as necessary, the main emphasis will be on political, administrative and military developments.

Text: Allan M. Ward, Fritz M. Heichelheim, Cedric A. Yeo, **A History of the Roman People**, 6th ed., Pearson, 2014.

Course requirements: the course will be based on the textbook (chapters 1 – 17) and attendance at my lectures, which will seek to highlight important themes in Roman Republican history. There will be one essay required, which will be written on a topic drawn from a list which I shall post, and a final examination. Each item will be worth 50% of the final grade.

Oct.21: Rome's expansion through the Mediterranean (ch. 9)

Nov. 4: Rome in the second century B. C. (chs. 10-11)

Nov. 11: The Gracchi (ch. 12)

Nov. 18: Marius and Sulla and the rise of the generals (chs. 13 – 14)

Nov. 25: Civil strife and the collapse of the Republic (chs. 15 – 16)

Dec. 2: The emergence of Augustus as emperor (ch. 17)

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
