Generic Calendar Blurb: Study of a period or theme in Greek History.

Winter 2020: This course focuses on relations between the Greeks and the Achaemenid Persian empire from the 6th century to the death of Alexander the Great in 323 BC. Problems of sources, the structure of the Persian empire and Greek states, warfare and diplomacy, cultural contacts and influences will be discussed in addition to the continuing impact interpretations of the “Persian Wars” have had on western civilization.

Required Text:

George Cawkwell, *The Greek Wars: The Failure of Persia* (Oxford UP 2005).

Full text of this book is available online from the MacOdrum Library (DS 274.2.G8C28)

Required readings in some primary sources (ancient literature both Greek and Persian) will be posted on cuLearn. See the schedule of lectures below.

The final date for voluntary withdrawal without academic penalty is **April 7, 2020**.

Tests: The midterm test and final exam will include short answer, and essay questions. There will be no aids allowed during tests and exams. **Make-up tests** are only given for valid reasons and the professor must be informed within 3 days of the test date. Appropriate documentation must be produced. Make-up tests are normally scheduled within one week of the original test and at the professor’s convenience. Students must produce their Carleton Student ID at the final exam.

Research Bibliography and Essay: Students should develop their essay topic **IN CONSULTATION WITH THE PROFESSOR**. All topics must be approved by the professor by **February 11, 2020**. Research on a topic that has not been approved will not be accepted or graded.

Both the annotated bibliography and final essay must be submitted in hard copy, preferably at the end of class on their due date.

You may ask for a brief extension, but otherwise the penalty for late submission will be 10% subtracted from the grade for each working day late. After five days, late work will receive a mark of zero.

Academic offences: All students are expected to know what constitutes an academic offence, to avoid committing academic offences, and to take responsibility for their academic actions. Academic offences include things like plagiarism, cheating, improper research, obstructing academic activity, double submission,

Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made. [More information.](#)

The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
