The object of the course is to study the nature of Roman historiography through reading of three of the major historical works written in what is called the grand style. The three works are: Livy's History from the Foundation of the City; Tacitus' Annals; and Ammianus Marcellinus' History. The English translations to be used (all published in the Penguin Classics series) are:

Livy, Early History of Rome, trans. A de Selincourt;

Tacitus, Annals of Imperial Rome, trans. Michael Grant;

Ammianus Marcellinus, The Later Roman Empire A.D. 353-378, trans. Walter Hamilton.

The three historians deal with the three epochs of Roman history (Livy, the Republic; Tacitus, the Early Empire; Ammianus, the Later Empire). Livy is probably the most influential of all the Roman historians; Tacitus and Ammianus (along with the Greek Thucydides) are probably the best historians of antiquity.

The schedule for the course will be approximately as follows:

Week 1: the origin of western historiography and the Greek background;

2: the development of Roman historiography;

3: historiography in the grand style;

4-6: Livy

7-9: Tacitus;

10-12: Ammianus;

13: the legacy of Roman Historiography.

The final grade for the course will consist of two components: an essay worth 40%, the topics for which will be distributed in the fourth class (Jan. 28) and which will be due at the seventh class (Feb. 18); and a final examination worth 60%.

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
