COURSE OBJECTIVES

Although most well-know for its Pharaonic legacy, there was also a rich and vibrant culture in Egypt under Greek and Roman rule in antiquity. During this later period new and innovative types of literature, science, philosophy, and religion were created along the banks of the Nile. This course will explore the social, political, literary, and religious dynamics of Egypt from the rise of the Ptolemies to the later Roman Empire. Emphasis will be placed on textual evidence, based on recent papyrological and codicological discoveries.

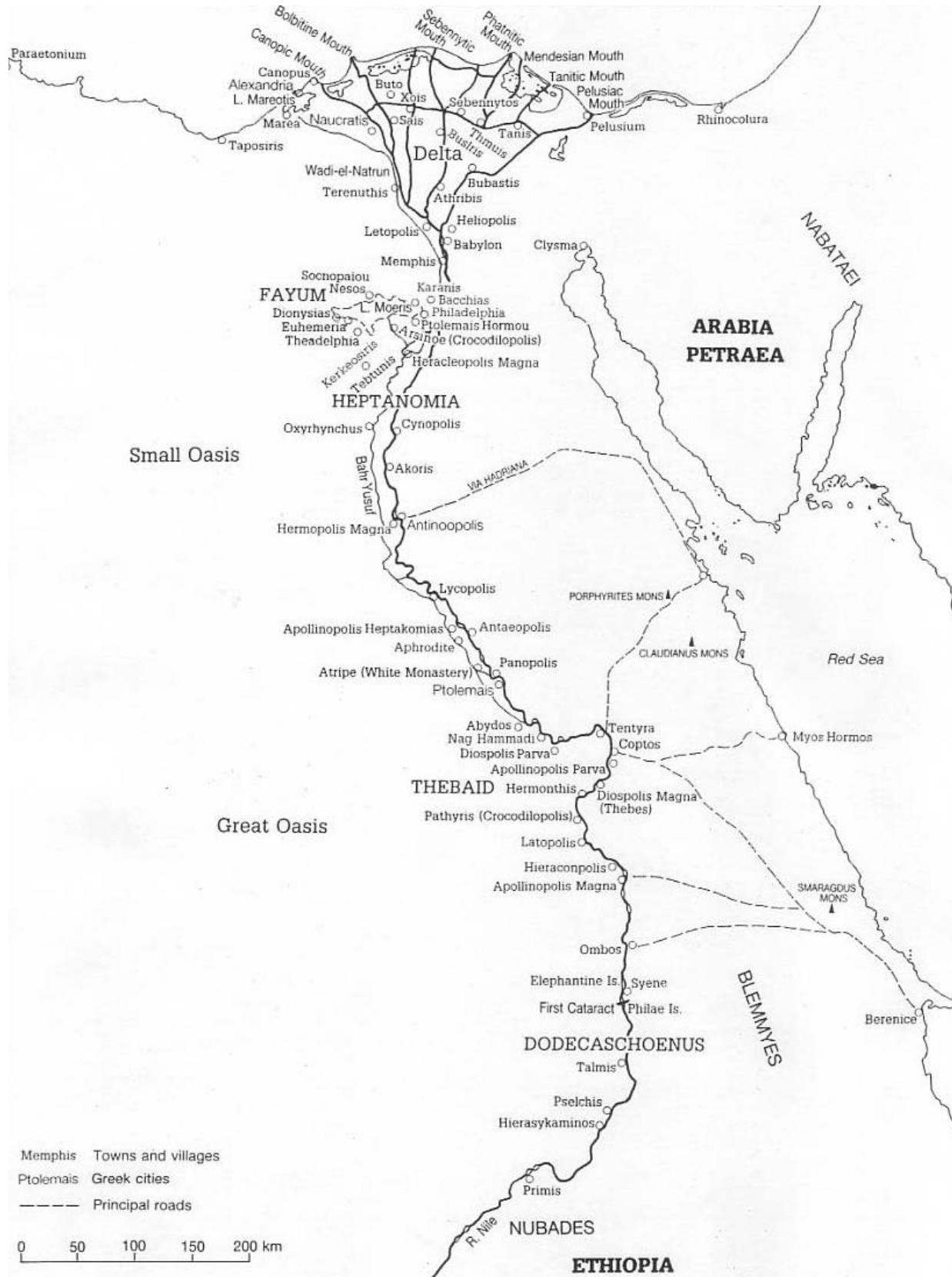

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
