

GREK 1005: Introduction to Greek I

Time & Location

Online hybrid, with synchronous sessions on **Weds 2:35-4:25**; other session asynchronous but in theory on **Mondays**

Course description

Greek I is the first of a three-semester sequence intended for students with little to no experience of the ancient Greek language. This first course will introduce students to the fundamentals of Greek grammar and vocabulary. We will aim to cover the first 5 chapters of Keller & Russell's *Learn to read Greek*, but the pacing will adapt to the needs of the class. Students should be prepared for careful study of readings, active participation in class, and timely completion of exercises assigned as homework. Two midterm exams and a final will be given.

Remote learning

- This course will be a hybrid, combining synchronous sessions with asynchronous lectures. The main *asynchronous* components are recorded lectures and homework

exercises. We will use the *synchronous* sessions for detailed explanations, feedback, and questions.

- Although the course is scheduled as two sessions, twice a week, I strongly suggest that you work every day on this material. Be prepared to invest time in doing homework and memorising paradigms if you would like to do well.
- I also encourage you to form study groups. As the Romans say, *docendo discimus*, “we learn by teaching [others]”.
- A suggested study schedule for each week
 - Monday: Do assigned readings and watch the recorded lecture.
 - Tuesday – Wednesday: Have a first go at homework exercises. Consult your study group with questions. Make a list of remaining problems.
 - **Wednesday afternoon: Attend synchronous session prepared with your questions so we can resolve them.**
 - Thursday – Friday: Complete and submit homework.
- The recorded lectures will be available by Monday of each week. Please watch them on something with a decently sized screen so you can read any text.
- The synchronous sessions will be hosted on either BigBlueButton or Zoom (TBD). There will be a link posted to Brightspace. **They will take place at our scheduled class time on Wednesdays at 2:35**, though they most likely will not take the whole two hours.

Exam notes

- The midterms and the final will all be online and open book/notes, and everyone will take them at the same time during one of the scheduled class times. The format will change depending on the material, but you should assume that, although it is open book, you will not have time to look up many things. Therefore, you should **prepare for exams as if they are *not* open book**, just with the safety net of looking up any small details you may be unsure about or vocabulary you have forgotten.
- The exams will each focus on material covered after the previous exam, but because each part of language learning builds upon the previous parts, they are in effect cumulative. *If you feel that you are falling behind, seek help immediately.*

Academic Integrity Policy (updated June 2021)

- failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.

Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the **instructor** concerned and for making alternate arrangements with the instructor and in all cases this must occur **no later than three (3) working days after the term work was due**. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
3. If a student is concerned the instructor did not respond to the request for academic accommodation or did not provide reasonable accommodation, the student should consult with the department/school/institute chair/director. If a mutually agreeable accommodation to complete course requirements prior to the course grade submission deadline cannot be achieved, the Associate Dean will become involved. If academic accommodation is not granted, and the student receives word **after** the academic withdrawal deadline, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses) for a final grade of WDN (Withdrawn) in the course(s). If academic

accommodation is not granted, and the student receives word **prior** to the academic withdrawal deadline, the student may elect to withdraw from the course(s).

4. Furthermore, if academic accommodation is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

1. be made in writing to the Registrar's Office **no later than three working days after the original final examination or the due date of the take-home examination**; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in [Carleton Central](#) within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published [fee deadlines](#) and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published [deadlines](#) (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the “Calculate amount to pay” button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.
