Course Overview

Intermediate Greek I aims to continue the study of Greek grammar. Although we can aim to reach the end of Hansen and Quinn's *Greek: an intensive course*, in practice we will adapt to the previous experience and preparation of students. The contents of the course will therefore be very flexible. There will certainly be a large portion of review, but after this, the proportions of new syntactical material and practice reading extended passages of Greek prose will depend on time and the comfort of the students. We may proceed by taking up a text and reviewing/learning the necessary syntax as we go.

Required Text

Hansen, H. and Quinn, G. M. 1992. *Greek: an intensive course*, 2nd edition (ISBN: 9780823216635)

The choice of reading texts will be decided through discussion. Possibilities include Plato *Apology*, Xenophon *Anabasis*, Lysias I, and others.

Grading

The grading scheme below will be somewhat flexible, depending on how each student learns best. For instance, we could institute a policy where half the marks lost on a quiz can be made up through a subsequent assignment. We will figure this out as the semester goes on.

- Attendance and participation: 20%
- Homework assignments: 25%
- Quizzes: 20%
- Midterm exam: 15%
- Final exam: 20%

Notes

- Regular attendance is essential. Regular attendance includes the assumption that you come prepared to class and be actively engaged during class. You are allowed one unexcused absence before your grade starts to become affected. More than three unexcused absences will jeopardise continued participation in the course.
- The **quizzes** are short, in-class assessments. The lowest quiz grade will be dropped. The **midterm** takes about an hour during class. The **final** will be during exam period.

Deferred Term Work

Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
