COURSE DESCRIPTION:

This course will introduce students to the language of Homeric Greek, including the idiosyncrasies of both its accidence and syntax. At the same time it will examine the prosody of the Homeric hexameter. After a general introduction, students will be required to prepare and translate approximately 60 lines per week of Book I of Homer's *Iliad*. Roughly 2 hours of each class will be devoted to the above.

[Since it is assumed by the instructor that students have not had an opportunity to review the syntax of Attic prose since the time they took GREK 2000, the third hour will be devoted to reviewing the grammar of Attic prose in order that students do not forget the basic elements of it which they will require for GREK 3901. A speech of the Attic orator Lysias will be used for this purpose.]

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They range from a mark of zero for the plagiarized work to a final grade of “F” for the course, and even suspension from all studies or expulsion from the University.
