Course Description

This course is designed for beginners in Latin. It will introduce students to the grammatical structure of Latin, which is very different from that of English, and give practice in reading Latin and translating from one language to the other.

By learning Latin you will gain access in the original to the rich Latin literature of the Classical period, as well as that of the Middle Ages and Renaissance. Latin remained the main language of international communication until the nineteenth century. It is also the mother language of the Romance languages (Italian, French, Spanish, Portuguese, Romanian, etc.) and is the source of about 60-70% of English vocabulary.

Learning Latin requires a readiness to learn not only vocabulary but also many grammatical forms. This is because Latin (like Russian, for example) is an inflected language, one in which changes in word endings are used to make the words' functions clear. The vocabulary and forms must be memorized daily in order to make good progress. Come to class on time and prepared. **Steady work throughout the term is essential.**

This course is the prerequisite for LATN 1006A in which students continue their learning of Latin with the same book and approach.

Required text

Wheelock, F. M., *Wheelock's Latin* (7th Edition; revised by Richard A. LaFleur) (New York, 2011) [available in the bookstore or for purchase online]

Homework consists of review of the material, memorization of vocabulary and forms, and translation. **Oral class work** consists of reading the Latin out loud and going over the translation done for homework. There will be oral exercises and practice every class; if there is a good reason for not participating, speak to me in advance of the class and alternate arrangements will be made. Regular attendance and active participation is critical to student success.

There will be a **quiz** after learning the new material of most chapters (but not right before the tests and exam). Each quiz will test the new vocabulary and forms, and will have translation of sentences (Latin to English, English to Latin).

The **tests** and **exam** will begin with recent vocabulary and forms, and will include analysis and identification of morphology and syntax. Testing will conclude with sentences of translation from English into Latin and Latin into English.

Throughout the semester, the material we translate will give insight into Roman culture, history, and literature.

Deferred Term Work

Deferred Exams

Students who do not write/attend a final examination because of illness of other circumstances beyond their control may apply to write a deferred examination.

- 1. be made in writing to the Registrar's Office **no later than three working days after the original final examination or the due date of the takehome examination;** and
- 2. be fully supported by appropriate documentation and in cases of illness by a medical certificate dated no later than one working day after the examination or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office forms and fees page.

The granting of a deferral also requires that the student has performed satisfactorily in the course according to the evaluation scheme established in the Course Outline, excluding the final examination for which deferral privileges are requested. Reasons for denial of a deferral may include, among other conditions, a failure to (i) achieve a minimum score in the course before the final examination; (ii) attend a minimum number of classes; (iii) successfully complete a specific task (e.g. term paper, critical report, group project, computer or other assignment); (iv) complete laboratory work; (v) successfully complete one or more midterms; or (vi) meet other reasonable conditions of successful performance.
