### COURSE DESCRIPTION

The aim of this course is to introduce students to the basics Latin grammar and vocabulary in order to read simple sentences and texts. Along the way, there will be extra vocabulary and cultural notes and short readings from Roman authors to give a glimpse into their world. In-class activities will be used to re-enforce knowledge as it is acquired.

### TIPS FOR SUCCESS



**ATTENDANCE:** The only way to truly keep up and track your progress is to attend class.

## Deferred Term Work

---

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

## Deferred Final Exams

---

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made. [More information.](#)

The application for a [deferral](#) must:

1. be made in writing or online to the Registrar's Office no later than **three working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination.
