Course Description

Introduction to Latin II [0.5 credit] A course for students with some previous knowledge of the language: study of grammatical forms and constructions; acquisition of reading skills.

Prerequisite: LATN 1005 or equivalent.

This course continues the foundational study of Latin with the same textbook as LATN 1005: we learn how the Latin language works through analysis of its patterns. The class provides explanations of grammar and syntax, and then immediate practice and reinforcement of the constructions and vocabulary, while we read passages of Latin that are increasingly close to the actual words of ancient authors like Terence, Cicero, Vergil, Livy, Ovid, and Tacitus, to name just a few. As we translate, we will also learn about the cultural context, history, and literature of the Romans. Students will come to appreciate how every translation is an interpretation, especially with a language as succinct as Latin.

This course is the prerequisite for LATN 2200.

Homework consists of reading and review of the chapter's material, memorization of vocabulary and forms, and translation of the sentences (*exercitationes* and *sententiae antiquae*), both from Latin to English and from English to Latin. Students must not use Google translate or similar tools. Students will themselves dissect the sentences in each chapter, applying the grammatical rules learned from this class. **Oral class work** consists of reading the Latin out loud and going over the translation done for homework. There will be oral exercises and practice every class; if there is a good reason for not participating, speak to me in advance of the class and alternate arrangements will be made. Come to class on time and prepared. **Regular attendance and active participation lead to student success.**

There will be a **check** after learning the new material of most chapters at the beginning of almost every class (but not right before the tests and exam). See the schedule below. Each check will test the student's memorization of new vocabulary and forms, and will have translation of sentences (Latin to English, English to Latin) to check for comprehension of syntax (how the words fit together). The checks on chapters 16 and 17 (January 8 and 15) will provide early feedback. They will be returned by January 31, which is before the last date to withdraw from a course with a full fee adjustment. If you miss a check, make arrangements to do an alternate check as soon as possible. There are 10 checks, all of which count toward the final mark. The purpose of these frequent checks is to encourage students to stay on top of the material, since we build on what we have learned; Latin is cumulative.

The **tests** and **exam** will include analysis and identification of morphology and syntax, and sentences of translation from English into Latin and Latin into English. The test through chapter 20 on February 5, and the test through chapter 25 on March 17, will take place in the first hour of class; the second part of the class will introduce new material. The last day for academic withdrawal is March 15, so a student's decision will be based on 8 chapter checks and the first test. The exam is formally scheduled during the exam period.

NOTE: As per the Policy, students are to speak with/contact their instructor before submitting a request for Academic Consideration. Requests are not automatically approved. Approving and determining the accommodation remains at the discretion of the instructor. Academic Integrity Policy

The University Academic Integrity Policy defines plagiarism as 'presenting, whether intentionally or not, the ideas, expression of ideas or work of others as one's own.' This includes reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source. Examples of sources from which the ideas, expressions of ideas or works of others may be drawn from include but are not limited to books, articles, papers, literary compositions and phrases, performance compositions, chemical compounds, artworks, laboratory reports, research results, calculations and the results of calculations, diagrams, constructions, computer reports, computer code/software, material on the internet and/or conversations.

Examples of plagiarism include, but are not limited to:

- any submission prepared in whole or in part, by someone else, including the unauthorized use of generative AI tools (e.g., ChatGPT)
- using ideas or direct, verbatim quotations, paraphrased material, algorithms, formulae, scientific or mathematical concepts, or ideas without appropriate acknowledgment in any academic assignment
- using another's data or research findings without appropriate acknowledgment
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one's own
- failing to acknowledge sources with proper citations when using another's work and/or failing to use quotations marks."

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor.

The Associate Dean of the Faculty follows a rigorous process for academic integrity allegations, including reviewing documents and interviewing the student, when an instructor suspects a violation has been committed. Penalties for violations may include a final grade of "F" for the course.

Deferred Final Exams

Students who are unable to write a final examination because of extenuating circumstances, as defined in the [Academic Consideration Policy](#), may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

1. be made in writing to the Registrar's Office no later than **three (3) working days** after the original final examination or the due date of the take-home examination; and,
2. be fully supported by appropriate documentation. In cases of short-term extenuating circumstances normally lasting no more than five (5) days, students must complete the University's self-declaration form which is included in the deferral application found on the [Registrar's Office website](#). Additional documentation is required in cases of extenuating circumstances lasting longer than five (5) days and must be supported by a medical note specifying the date of onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office [here](#).

Deferred Term Work

In some situations, students are unable to complete term work because of extenuating circumstances beyond their control, which forces them to delay submission of the work. Requests for academic consideration are made in accordance with the [Academic Consideration Policy for Students in Medical or Other Extenuating Circumstances](#).

1. Students who claim short-term extenuating circumstances (normally lasting up to five days) as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor. If the instructor requires supporting documentation, the instructor may only request submission of the University's self-declaration form, which is available on the [Registrar's Office website](#). The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule.
 - a) Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
2. In cases where a student is not able to complete term work due to extenuating circumstances lasting for a significant period of time/ long-term (normally more than five days), the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
3. If a student is concerned the instructor did not respond to the request for academic consideration or did not provide reasonable accommodation, the student should follow the appeals process described in the [Academic Consideration Policy](#).
4. If academic consideration is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury, or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines.
