Textbook: Frederick M. Wheelock and Richard A. LaFleur, **Wheelock's Latin**, 7th ed., Harper Collins 2011.

This course, like its prerequisite (LAT 1005), will be based on **Wheelock's Latin**. During the winter term I intend to cover chs. 13-24 (or 25), that is, an average of a little over one chapter per week. In the first class I shall quickly review the grammatical material in chs. 1 – 12. Thereafter you should make sure that you stay at least one chapter ahead of the schedule. You should also cover the self-tutorial exercises either before or after the relevant classes.

In the classes themselves I shall concentrate on the grammar, vocabulary, and the exercises, primarily the **exercitationes** and the **sententiae antiquae**. As you will have already discovered, a lot of memorization is necessary. There are, however, strategies to make memorization easier. You should identify in class anything that is not clear to you, so that I can help clarify it. PASS is also very effective, and if you feel that you are struggling, or simply want to do better, I urge you to make use of it.

There will be three in-class tests, based primarily on the material in chs. 13-15, 16-18 and 19-21 respectively, although there will be some accumulation. Each test will be worth 20% of the final grade. The formally scheduled final examination will be worth 40% of the final grade, and will cover all the course material. Those who show significant improvement over the course will have their final grade adjusted upwards.

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
