Course Description:

This course is designed for students who have successfully completed LATN 2200 or the equivalent. It is a continuation of the study of grammar and reading Latin texts. In the first few weeks, we will complete the material in *Wheelock's Latin*, chapters 37-40; we will then have covered all the main Latin grammatical constructions.

For the rest of the semester, we will read a selection from Latin epic poetry: Ennius, Lucretius, Catullus, Vergil, Ovid, Lucan, and Silius Italicus. The chief goal is to develop a facility with translating passages of Latin; to this end we will read about 20-30 lines per class (less at the beginning and more at the end of the semester). In addition, we will familiarize ourselves with the literary and cultural context of the different epic writers and their times. The chronological period is extensive, from the mid-Republic into the empire. Students will read examples of Homeric-style epic, historical epic, and the epyllion or mini-epic. Our goal is to understand both epic as a genre and Roman epic as a construction of Roman identity. Students will learn about poetic and rhetorical conventions and will be encouraged to develop their own critical approach to the texts through a close reading of the passages. This course is the prerequisite for LATN 3900 in which students continue their learning of Latin through the reading of ancient authors.

Evaluation: The final grade components are:

Class participation includes attendance and preparation of 20-30 lines of Latin per class, either in Wheelock or in our *Latin Epic Reader*. This class requires extensive independent preparation. Students will be urged to move away from writing out a translation and to move toward reading the Latin and understanding the different possible interpretations of the Latin text. For each selection, students will memorize their vocabulary lists, figure out the grammar and syntax, and read the commentary for greater understanding of the context.

The January 31st **Test** on Wheelock chapters 37-40 will include vocabulary, principal parts, the synopsis of a verb, and translation from Latin into English with grammatical questions.

The March 14th **Test** and the April **Final Examination** may include vocabulary, the synopsis of a verb, translation, identification of grammar and syntax, commentary on the poetry, scansion of the dactylic hexameter, historical questions, translation of an unseen passage at sight, and short essay questions. The exam will be formally scheduled in the April exam period.

Academic Integrity Policy (updated June 2021)

Plagiarism is presenting, whether intentionally or not, the ideas, expression of ideas, or work of others as one's own.

Penalties are not trivial. They can include a final grade of "F" for the course.

Deferred Term Work

In some situations, students are unable to complete term work because of illness or other circumstances beyond their control, which forces them to delay submission of the work.

- 1. Students who claim illness, injury or other extraordinary circumstances beyond their control as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor and in all cases this must occur no later than three (3) working days after the term work was due. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
- 2. In cases where a student is not able to complete term work due to illness or injury for a significant period of time/or long term, the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
- 3. If a student is concerned the instructor did not respond to the request for academic accommodation or did not provide reasonable accommodation, the student should consult with the department/school/institute chair/director. If a mutually agreeable accommodation to complete course requirements prior to the course grade submission deadline cannot be achieved, the Associate Dean will become involved. If academic accommodation is not granted, and the student receives word **after** the academic withdrawal deadline, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses) for a final grade of WDN (Withdrawn) in the course(s). If academic

- accommodation is not granted, and the student receives word **prior** to the academic withdrawal deadline, the student may elect to withdraw from the course(s).
- 4. Furthermore, if academic accommodation is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. Deferred Final Exams

Students who are unable to write a final examination because of a serious illness/emergency or other circumstances beyond their control may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

- 1. be made in writing to the Registrar's Office no later than three working days after the original final examination or the due date of the take-home examination; and,
- 2. be fully supported by appropriate documentation and, in cases of illness, by a medical certificate dated no later than one working day after the examination, or by appropriate documents in other cases. Medical documents must specify the date of the onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office here.

Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in <u>Carleton Central</u> within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published <u>fee deadlines</u> and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published <u>deadlines</u> (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the "Calculate amount to pay" button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.
