Course Description

Through translation and analysis of the poetry of Catullus, we will exercise Latin language skills and familiarize ourselves with the literary and cultural context of Late Republican Rome. Students will learn about the conventions of lyric poetry and will be encouraged to develop their own critical approach to the poetry, first by close reading of the poems, and then by becoming acquainted with the scholarly discussion, leading to an individual presentation.

Class participation includes attendance and preparation of the text as well as an active engagement with the interpretation of the text. We will be reading about 40-80 lines of Catullus per class (less at the beginning and more at the end of the semester), as well as practicing reading Latin at sight. Testing will include translation, commentary, identification of grammar and syntax, discussion of historical and literary context, synopsis of a verb, metrical scansion, memorization of assigned lines, translation of an unseen passage at sight, and essay questions.

PLAGIARISM

The University Senate defines plagiarism as “*presenting, whether intentional or not, the ideas, expression of ideas or work of others as one’s own.*” This can include:

- reproducing or paraphrasing portions of someone else’s published or unpublished material, regardless of the source, and presenting these as one’s own without proper citation or reference to the original source;
- submitting a take-home examination, essay, laboratory report or other assignment written, in whole or in part, by someone else;
- using ideas or direct, verbatim quotations, or paraphrased material, concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another’s data or research findings;
- failing to acknowledge sources through the use of proper citations when using another’s works and/or failing to use quotation marks;
- handing in “*substantially the same piece of work for academic credit more than once without prior written permission of the course instructor in which the submission occurs.*”

Plagiarism is a serious offence which cannot be resolved directly with the course’s instructor. The Associate Deans of the Faculty conduct a rigorous investigation, including an interview with the student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of “F” for the course
