#### **Required Texts:**

- 1. Cicero, <u>De Re Publica</u> books 2 and 6 (ed. J. E. G. Zetzel), Cambridge University Press: \$54.95 CAD direct from publisher
- 2. Augustine, De Civitate Dei book 3 (ed. P. G. Walsh), Liverpool University Press
  - a. Scans to be provided by professor: free
- 3. A Latin dictionary of your choosing: price varies

#### **Course Goals and Assessments:**

- 1. Improve Latin reading, both prepared at home and at sight in class (preparation/participation)
- 2. Assess international scholarship on Cicero and Augustine (preparation, response papers)
- 3. Analyze Cicero's and Augustine's Latin (response papers, project)

#### **Preliminary schedule:**

We will work as quickly as we are able, but here is the general outline:

September: Cicero, DRP 2

October: Cicero, DRP 6 (Somnium Scipionis) November/December: Augustine, CD 3

#### **Paper Guidelines:**

These should be researched response papers of approximately 1200 words. I have given you one book chapter or article to start with for each question; you should find at least three more on your own. Latin should play a starring role in your response -- make sure that you are answering the prompts below based on the language you've read, rather than the general context. I am more interested in your Latin knowledge than your English prose style.

If there's a topic that catches your eye while you're reading, please feel free to write on that instead of the prompts below! The general idea is that the first paper is on Cicero alone, the second on Cicero and Augustine together.

- (a) How well does Cicero's discussion of Roman history (2.2.4-2.37.62) explicate his
  description of the ideal statesman/citizen in book 6? Start with the discussion of Asmis,
  "Cicero Mythologus"; you may also find it helpful to read the description of the
  rector/gubernator rei publicae in book 5.6-8 (translation is fine!)
  - (b) What role does the astrological narrative of book 6 play in Cicero's conception of the state? Start with the discussion of McConnell, "Magnitudo animi"
- 2. (a) What role does the work of Augustine play in the transmission of Cicero, and how can we better understand Cicero's work with reference to Augustine? Start with the discussion of Zetzel, *The Lost Republic* ch 9.
  - (b) Augustine and Cicero both wrote in the aftermath of destruction (Cicero under Caesar, and Augustine after the sack of Rome). What ideals did they focus on at a time of great societal stress? Start with the discussion of <a href="Conybeare">Conybeare</a> in Being Christian in Late Antiquity ch. 8

#### **Commentary assignment:**

For this assignment, you will write a commentary on a section of either Cicero or Augustine that we have not covered in class. This commentary should follow the format of the commentaries that we have been using in class, and cover both interesting lexical points as well as grammatical aids. Because sections vary in length and complexity, you should aim to comment on a section of approximately 50 words. You may find the <u>Library of Latin Texts</u> helpful for understanding how rare a word is, whether in a specific author or Latin in general; <u>Logeion</u> likewise supplies some information about word frequencies. This commentary should be approximately one page long.

#### **Assignment policies:**

- All papers are due at midnight on the due date
- Please submit papers via email rather than Brightspace
- You may have an extension of up to one week on any assignment (no questions asked) if you ask at least the calendar day before the due date; later requests may require explanation
- Late penalties will be assessed at 5% per day
- Citations may be in any format, provided that an author, date, and page number are provided
- Generative AI is not permitted in these assignments, although the use would not help you since it does not seem to be very good at Latin

An important and valuable component of the learning process is the progress a student can make as a result of interacting with other students. In struggling together to master similar concepts and problems

and in being exposed to each other's views and approaches, a group of students can enhance and speed up the learning process. Carleton University encourages students to benefit from these activities which will not generally be viewed as a violation of the Policy. With the exception of tests and examinations, instructors will not normally limit these interactions.

The <u>Student Rights and Responsibilities Policy</u> governs the non-academic behaviour of students. Carleton University is committed to building a campus that promotes personal growth through the establishment and promotion of transparent and fair academic and non-academic responsibilities.

#### Deferred Term Work

In some situations, students are unable to complete term work because of extenuating circumstances beyond their control, which forces them to delay submission of the work. Requests for academic consideration are made in accordance with the <u>Academic Consideration Policy for Students in Medical or Other Extenuating</u> Circumstances.

Students who claim short-term extenuating circumstances (normally lasting up to five days) as a reason for missed term work are held responsible for immediately informing the instructor concerned and for making alternate arrangements with the instructor. If the instructor requires supporting documentation, the instructor may only request submission of the University's self-declaration form, which is available on the <a href="Registrar's Office">Registrar's Office</a> website. The alternate arrangement must be made before the last day of classes in the term as published in the academic schedule.

- 1. Normally, any deferred term work will be completed by the last day of term. In all cases, formative evaluations providing feedback to the student should be replaced with formative evaluations. In the event the altered due date must extend beyond the last day of classes in the term, the instructor will assign a grade of zero for the work not submitted and submit the student's earned grade accordingly; the instructor may submit a change of grade at a later date. Term work cannot be deferred by the Registrar.
- 2. In cases where a student is not able to complete term work due to extenuating circumstances lasting for a significant period of time/ long-term (normally more than five days), the instructor and/or student may elect to consult with the Registrar's Office (undergraduate courses) or Graduate Registrar (graduate courses) to determine appropriate action.
- 3. If a student is concerned the instructor did not respond to the request for academic consideration or did not provide reasonable accommodation, the student should follow the appeals process described in the <u>Academic Consideration Policy.</u>
- 4. If academic consideration is granted, but the student is unable to complete the accommodation according to the terms set out by the instructor as a result of further illness, injury, or extraordinary circumstances beyond their control, the student may submit a petition to the Registrar's Office (undergraduate courses)/Graduate Registrar (graduate courses). Please note, however, that the course instructor will be required to submit an earned final grade and further consideration will only be reviewed according to established precedents and deadlines. ### **Deferred Final Exams**

Students who are unable to write a final examination because of extenuating circumstances, as defined in the <u>Academic Consideration Policy</u>, may apply for accommodation. Normally, the accommodation for a missed final examination will be granting the student the opportunity to write a deferred examination. In

specific cases when it is not possible to offer a deferred examination, and with the approval of the Dean, an alternate accommodation may be made.

The application for a deferral must:

- 1. be made in writing to the Registrar's Office no later than three (3) working days after the original final examination or the due date of the take-home examination; and,
- 2. be fully supported by appropriate documentation. In cases of short-term extenuating circumstances normally lasting no more than five (5) days, students must include the University's self-declaration form, which can be found on the Registrar's Office website. Additional documentation is required in cases of extenuating circumstances lasting longer than five (5) days and must be supported by a medical note specifying the date of onset of the illness, the (expected) date of recovery, and the extent to which the student was/is incapacitated during the time of the examination. The University's preferred medical form can be found at the Registrar's Office here.

# **Academic Consideration Policy**

As per the <u>Academic Consideration Policy</u>, if students encounter extenuating circumstances that temporarily hinder their capacity to fulfil in-class academic requirements, they can request academic consideration. The Academic Consideration for Coursework is only available for accommodations regarding course work. Requests for accommodations during the formal exam period must follow the <u>official deferral process</u>.

NOTE: As per the Policy, students are to speak with/contact their instructor before submitting a request for Academic Consideration. Requests are not automatically approved. Approving and determining the accommodation remains at the discretion of the instructor. Students should consult the course syllabus about the instructor's policy or procedures for requesting academic consideration. More information here.

#### Financial vs. Academic Withdrawal

Make sure that you are aware of the separate deadlines for Financial and Academic withdrawal!

Making registration decisions in Carleton Central involves making a financial and academic commitment for the courses you choose, regardless of attendance. If you do not attend, you must withdraw in Carleton Central within the published deadlines to cancel your registration. A fee adjustment is dependent on registration being canceled within the published <u>fee deadlines</u> and dependent on your course load. A course dropped after the deadline for financial withdrawal will receive a grade of Withdrawn (WDN), which appears on your official transcript.

Even if you miss the deadline for financial withdrawal, you might decide to drop a course to avoid a failure or a poor grade showing up on your student record and bringing down your CGPA. It is your responsibility to drop the course via Carleton Central within the published <u>deadlines</u> (see Academic Withdrawal).

If you are considering withdrawing from a course, you may want to talk to an advisor first. Course withdrawal may affect your student status, as well as your eligibility for student funding, immigration status, residence accommodation and participation in varsity sports, etc. Additionally, remember that once you choose your courses, you must use the "Calculate amount to pay" button to determine the correct amount of fees to pay.

Carleton Central is your one-stop shop for registration activities. If you are interested in taking a course, make sure to complete your registration. Simply attending a course does not mean you are registered in it, nor is it grounds for petition or appeal.
