HOW DO I READ MY AUDIT?

- CONTACT IIS@CARLETON.CA TO GET A COPY OF YOUR AUDIT AND GO OVER THE REQUIREMENTS OF YOUR PROGRAM WITH OUR UNDERGRADUATE ADMINISTRATOR AT THE END OF EACH TERM TO ENSURE THAT YOU'RE ON TRACK.

REGISTRATION TIPS (PAGE 1 OF 2)

- Review your audit to confirm your year standing and which courses you are required to take.
- Get the list of courses that are being offered in the summer or fall and winter semesters. It is important that you register for both your fall and winter courses as soon as your Time-Ticket allows.
- When building your schedule, begin by choosing the courses that fulfill your program requirements followed by electives that fit into your schedule.
- Take note of your registration
- Over the course of your program you can enroll in a maximum of 7.0 1000-level courses. Registering in more than this results in forfeited courses that are not applied to your audit.
- When registering in courses outside of The Institute of Interdisciplinary Studies you should verify pre-requisites by reviewing the course in the [Undergraduate Calendar](#).

REGISTRATION TIPS (PAGE 2 OF 2)

- If you would like to register for a course but are restricted because you do not meet the prerequisites or it is restricted to students in a different program, you can submit an [Override Request](#). Please be certain to provide a detailed rationale for WHY you want/need to take the course as our decisions are based on available space, year in degree program, and rationale.
- Once you have registered, **check your [audit](#)**. All of the courses you have chosen should be in one of the line items. There should be nothing in the section at the end of the audit called “Courses set aside”. If there are, you have registered in a course that is not acceptable for your program and you should review the program requirements. Questions about your audit should be sent to IIS@carleton.ca.

ELECTIVE CREDITS

- CREDITS NOT INCLUDED IN THE MAJOR CGPA
 - 8.0 CREDITS ON FREE ELECTIVES (CAN BE HUMR OR OTHER) TO BE COMPLETED OVER THE ENTIRETY OF THE DEGREE

F.A.Q.S

- **WHAT IS A FREE ELECTIVE?**

A FREE ELECTIVE IS A COURSE THAT MAY BE TAKEN FROM WITHIN YOUR MAJOR DISCIPLINE (HUMR) OR FROM ANOTHER FIELD OF STUDY.

- **WHAT IS AN 'ELECTIVE NOT IN CHST'?**

AN 'ELECTIVE NOT IN HUMR' IS A COURSE THAT IS TAKEN IN ANOTHER FIELD OF STUDY. THAT IS, IT CANNOT HAVE A COURSE CODE BEGINNING WITH 'CHST'.

F.A.Q.S (CONTINUED)

- **WHAT IS MY YEAR-STANDING?**

YEAR STANDING IS BASED ON THE NUMBER OF CREDITS YOU HAVE COMPLETED SUCCESSFULLY THAT ARE BEING APPLIED TO YOUR DEGREE.

FIRST YEAR STANDING: FEWER THAN 4.0 CREDITS

SECOND YEAR STANDING: 4.0 THROUGH 8.5 CREDITS

THIRD YEAR STANDING : 9.0 THROUGH 13.5 CREDITS

FOURTH YEAR STANDING : 14.0 OR MORE CREDITS (ONLY FOR STUDENTS IN 20.0 CREDIT DEGREE PROGRAMS)
