Students will also theorize the intersectionality of race, racism, racialization, racial and ethnic formations, nationalism, and colonialism in a contemporary context.	60	1
CHST 4102A	Queer and Trans Youth [0.5 credit]	In-Person	Mondays, (1435 – 1725)	An examination of the ways that queer and trans youth have been conceptualized in research, media, literature, policy, and education. A range of multimedia sources will be used to explore the ways queer and trans youth are using language to render themselves intelligible.	30	-
