# SESSION 2: Reconciliation and CRAN: Knowing, Acting and Practice for Child and Youth Rights and Participation 10:45 - 12:15

\*The format for this session is presentation of tweets, large group discussion followed by five speakers.

Drawing on children's and young people's perspectives noted in the STM reports, we invite you to share with the group a 75-word tweet that captures what is/can happen within your sector to foster reconciliation, belonging and promoting culturally based equity. We'll read them aloud and discuss during the CRAN meeting. The tweet might describe something you have attempted to do, a project you aspire to undertake, a strategy for addressing systemic barriers and/or social inequalities, a recommended action or practice for your sector, for example.

Following the tweets and discussion, we will hear from five colleagues who have volunteered to speak for 5 minutes to what they perceive are the connections between knowing, acting, and practice for fostering reconciliation in children's rights contexts.

# Reflecting on Children's Rights in a Dynamic Global World: Accelerating Action on the UN Convention On The Rights of the Child

\*The format for this session is small group discussions. This is not a speakers panel.

As the world changes and presents new and ongoing challenges to children's lives and children's rights, it is crucial for CRAN to discuss, stay informed, and to proactively address some of these challenges across research, policy, advocacy, and professional contexts.

In small groups we will discuss and share knowledge and expertise regarding what we perceive to be connections between what young people have told us in the STM reports, what is happening within your sector, and what is happening in the world with children's rights and the UNCRC more broadly. Possible topics to discuss include: accountability and responsiveness in upholding children's rights, evolving challenges faced by children in Canada and/or globally, and strategies for accelerating action on the UN Convention on the Rights of the Child.

- 2. Within your sector, is there a key decision-maker(s) to whom we could send the Shaking the Movers reports? Can we collaborate on a list of potential 'movers' to engage with CRAN/STM?"
