# **EVALUATION**

- Formative Quiz III (25%), will be available on August 12, 2021through BS and will consist of multiple choice and short answer questions on the lectures and readings for 'Interpreting Legislation', 'Citizenship: Who Belongs? Who is Protected?', and 'Protecting Rights Inside and Outside the Constitution'.
- **Discussion Group attendance and participation** (25%), students will be expected to attend and participate in weekly discussion groups. The groups are run as chat sessions and accessed through BS; additional information about the groups will be shared by your TA before the first week of term.

#### Please note the following:
