COURSE DESCRIPTION

This online course provides an interdisciplinary introduction to the laws governing the relationship between the state and its citizens in a Canadian context. It will address some of the key theories, values and challenges associated with this relationship, and examine key topics such as the Charter of Rights and Freedoms, theories of the state, administrative law, and public international law. Throughout the video lectures, the role and limits of the law and the courts will be discussed from legal, political and historical perspectives.

At the end of the course, students should be able to: 1) demonstrate an introductory level of knowledge of key theories, questions, and debates on topics covered in the course; 2) identify basic legal issues, rules, and questions in relation to the assigned readings; 3) critically reflect on the political and historical context in which the Charter and the courts operate; and 4) construct arguments in support of particular positions related to the course topics, and show an awareness of alternative views to these positions.
