CALENDAR COURSE DESCRIPTION

The concept of law, leading theories of law and related concepts such as rules and obligations, power and authority, coercion, and justice.

COURSE DESCRIPTION

In this series of lectures, we will consider some of the central issues that shape philosophical inquiry into the concept of law. As will become clear, the problem of wicked or, better, "unjust" law motivates such inquiry. Even if the philosophy of law operates in abstraction, the cutting-edge of philosophy of law informs practical issues relating to the rights of legal subjects who may find themselves victims of official abuses of power. As well, the philosophy of law sheds light on fundamental questions about the legitimacy of a given legal order and how far that order is a source of binding obligation. Philosophy of law is thus informed by a concern to deal with what we may refer to as legal pathology.

REQUIRED TEXTS

All relevant materials will be provided on Brightspace. Note I do not lecture with slides. Rather, the lectures are a movement through arguments in legal theory. However, you may record the lectures.

EVALUATION

Standing in a course is determined by the course instructor, subject to the approval of the Department and of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Department and the Dean.

There are three assignments that require you to perform specific writing tasks of about 600-800 words that require you to either summarize or evaluate specific aspects of a reading or more than one reading. There will be specific instructions attached to each assignment and you can expect each assignment to get progressively more difficult on the basis that you are acquiring more knowledge as the lectures progress.

Each assignment is worth approximately 33% of the final grade. Keep in mind that if you do not attend class, you will likely find these assignments extremely difficult to complete.
