#### **CALENDAR COURSE DESCRIPTION**

Introduction to legal rules and theoretical approaches for critically understanding the creation, interpretation and enforcement of those rules; the role of judges, juries, lawyers, and lay persons; adjudication and alternative dispute resolution; relationship of law with social change and justice; challenges of access to justice.

### **COURSE DESCRIPTION**

This course provides a basic introduction to the social and conceptual foundations of law and socio-legal studies. As such, it considers the social, historical, political, and economic dimensions of the law and legal system, exploring the relationship between law and society.

The course consists of both lectures and discussion groups.

Lectures are delivered "asynchronously". This means that there are *no* live, scheduled meetings for lectures. Instead, I will be posting recorded lectures each week on our Brightspace course webpage. You will be free to watch them at times of your own choosing. Watching these lectures is vital to your success in the course, but you may watch them in accordance with your own schedule.

Discussion group meetings (i.e. tutorials) are held "synchronously". This means that our discussion group will meet each Thursday, from 11:35 a.m. to 12:30 p.m.. You are obligated to attend and participate in the discussion group each week.

# **RECOMMENDED TEXT**

The *only* recommended text for this course is:

There are *no* required texts for this course. It is up to you whether to obtain a copy of the above text, whether used or new. Completing the assigned readings, all from this text, will certainly help you to follow the lectures. However, doing so is not a specific requirement of the course.

Paperback copies of this text should be available at the <u>Carleton University Bookstore</u>. If you decide to obtain a copy, it is important that you obtain the most recent edition of this text, i.e. the one specified above, since its contents are significantly different from previous editions.

#### **EVALUATION**

There are four formal evaluation components in this course: two written assignments, attendance and participation in your weekly discussion group, and a single multiple-choice final examination to be held during the regular examination period in August 2022. Both written assignments must be completed and submitted electronically on Brightspace by 4:30 p.m. on the relevant due date.

Assignment 1 (20%): Short writing assignment, due Friday, July 22, 2022 by 4:30 p.m.

Assignment 2 (20%): Short case summary, due Friday, August 5, 2022 by 4:30 p.m.

Final examination (35%): A multiple-choice examination of all materials discussed in recorded lectures during the course of the semester. The examination will be held during the regular examination period in August 2022.

Discussion group (25%): Students will be expected to attend and participate in discussion groups each week.

All components must be successfully completed in order to get a passing grade

Grade appeals: Students who have questions about the grade they have received on a written assignment or who wish to challenge this grade must contact their Teaching Assistant via email to request a review within one week of the posting of grades. Students who are not satisfied with the outcome of a grade review, or who are denied a review, may appeal that outcome or denial to me within one week of receiving the Teaching Assistant's determination or denial.
