## **COURSE DESCRIPTION**

The aim of this course is to explore the relationship between the concepts of the rule of law or legality and the ideas of human rights and social justice. The question at stake is how far a state's formal commitment to the rule of law will commit public officials to recognizing the idea that all who are subject to legal authority – citizens as well as non-citizens – are moral persons possessed of fundamental rights. And whether a commitment to the rule of law also commits officials to a notion of substantive justice.

#### **EVALUATION**

The second part will involve a short critical writing component of about 250 words. The multiple choice is worth 40% while the written component is worth 60%.

The general goal of these assignments will be to test your ability to closely read, understand, and analyze an aspect of a given text.

To assist you, in each video lecture, I will try to contextualize the problem, question and the kind of argument presented in the reading through contemporary examples wherever possible. This means the video lectures will not necessarily be short; the length of the video will depend on the complexity of the argument or points I want to emphasize from the reading.
