CALENDAR COURSE DESCRIPTION

This course is about the enforcement of promises and agreements; basic doctrines and underlying principles of the law of contract; remedies for breach of contract; role of contract for economic, equitable and social purposes is also considered.

LEARNING OUTCOMES

Students will be introduced to contract law principles and how these are applied in everyday practice.

Students will acquire a variety of basic skills associated with the use of case law and legislation.

Finally, students will engage in an analysis of law where conflicting values exist (Property, Human Rights, ...etc.) as well as the fundamental law of contract – freedom of contract.

EVALUATION

- Any use of generative AI tools to produce assessed content is considered a violation of academic integrity standards.
- Al tools are not permitted in this course either for the mid-term or the final exam.

PLAGIARISM

The University Academic Integrity Policy defines plagiarism as "presenting, whether intentionally or not, the ideas, expression of ideas or work of others as one's own." This includes reproducing or paraphrasing portions of someone else's published or unpublished material, regardless of the source, and presenting these as one's own without proper citation or reference to the original source. Examples of sources from which the ideas, expressions of ideas or works of others may be drawn from include but are not limited to: books, articles, papers, literary compositions and phrases, performance compositions, chemical compounds, artworks, laboratory reports, research results, calculations and the results of calculations, diagrams, constructions, computer reports, computer code/software, material on the internet and/or conversations.

Examples of plagiarism include, but are not limited to:

- any submission prepared in whole or in part, by someone else, including the unauthorized use of generative AI tools (e.g., ChatGPT);
- using ideas or direct, verbatim quotations, paraphrased material, algorithms, formulae, scientific or mathematical concepts, or ideas without appropriate acknowledgment in any academic assignment;
- using another's data or research findings without appropriate acknowledgement;
- submitting a computer program developed in whole or in part by someone else, with or without modifications, as one's own; and
- failing to acknowledge sources through the use of proper citations when using another's work and/or failing to use quotations marks.

Plagiarism is a serious offence that cannot be resolved directly by the course's instructor. The Associate Dean of the Faculty conducts a rigorous investigation, including an interview with the

student, when an instructor suspects a piece of work has been plagiarized. Penalties are not trivial. They can include a final grade of "F" for the course.
