### CALENDAR COURSE DESCRIPTION

Origins and scope of the concept of the person in law and how concepts of legal personality change over time. Origins and scope of the concept of property and how concepts of property change over time.

### **COURSE DESCRIPTION**

This course examines two broader concepts of private law such as Person and Property. It includes the discussion of the origins and scope of the concept of person and property and how concepts of legal personality and concepts of property change over time. The course emphasizes the idea of legal personhood as constituting the legal subject and the idea of property as the legal object. The personhood of women, slaves, children, and corporations is studied along with origin stories, purposes, and types of property in Canada.

Throughout the term, we will explore questions including: What is the 'legal person'? Why does this construct matter (and to whom)? Who has or has not been a legal person (over time), and thus seen as capable of autonomous legal action and ownership? What is property as a legal construct? What can be owned, by whom, and on what terms? Who or what has been classified as (public or private) property and thus seen as giving rise to claims to exclude others and extract revenue from it? The course will also emphasize the role played by the state in the ordering of private law relations.

## **COURSE MODALITY & TECHNICAL REQUIREMENTS**

This course is an online course where the instructor and students share information, ideas, and learning experiences in a virtual course space. Asynchronous courses do not have live, scheduled meetings online. However, students are expected to remain up to date with the deadlines and due dates provided by the instructor. These courses require high-speed Internet access and a computer.

## **LEARNING OBJECTIVES**

Upon successful completion of the course, students will be able to:

- Define the legal concepts of person and property;
- Explain how the concepts of person and property constitute a taxonomy/framework by which law approaches ownership and decision-making;
- Investigate theoretical concepts related to persons and property in private law and key legal materials such as cases and legislation/statutes;
- Analyze and assess different aspects of legal inclusion and exclusion through personhood, property, and ownership using socio-legal concepts;
- Assess and critique the current categorization of persons and property in light of its adequacy to manage current challenges related to persons and property arising from corporate dominance, reconciliation with Indigenous peoples, ecosystem, and climate change.

You are required to read about 30 pages every week. To complete course assignments, you will need to have to use the Casebook readings. Since reading is mandatory in this course, get the book as early as possible. You will not be granted any extension excusing that you have no book or wrong edition.

#### **EVALUATION**

Standing in a course is determined by the course instructor subject to the approval of the Department and the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Department and the Dean.

Every student in this class must complete the following assessment criteria for full evaluation:

- 4. Assignment: 20% [Due on March 16]
- 5. Final Take-home Exam: 30% [TBA. To be scheduled during the formal examination period.]

Presentation and Critical Reflection [10%]: Every Wednesday I will hold an hour and a half session during our class time for meeting a group. I will make groups of 8 to 9 students each and a scheduled group will meet me during the session. You will be assigned a reading to present for 5-10 minutes during this session. I will post the groups in the first week of our class. If you see you are not on the list yet (due to late registration), let me know ASAP so that I can assign you to a group and you will be able to present. You will be required to present only once throughout the semester. To do this, you will read an assigned reading, make a summary of the reading, and present it during the live session. It is not a group work. The presentation starts from the 2nd week. Please follow the presentation schedule and don't miss your assigned presentation. The in-class presentation worths 5%.

During your presentation, you need to tell the audiences (me and other students):

1. Who is the author or if it is a case, cite the case name?

- 2. What is the reading about? Make a summary.
- 3. How the reading is relevant to Persons or Property?
- 4. Why do you think the reading you are presenting is relevant to our course?

In addition to the presentation, you are required to submit the summary and critical reflection of your works and the presentation slide (in a single document) based on the questions posed above for your presentation. Your summary should not exceed 350 words. The critical reflection worths 5%.

# 5 Reading and Lecture Quizzes [20%]:

For assessing a better understanding of the reading materials and lectures, students will be required to complete online quizzes. The quizzes are comprised of true/false and multiple-choice questions. There may be 8 quiz questions (4 from readings and 4 from lectures) students should answer for each quiz. A total of 7 weekly quizzes will be available but only your best 5 results will be counted towards your grade. Each of the five quizzes is worth 4%, for a total of 20% of the final grade. Each quiz question worths 0.5 point. To get the full 4%, you must have at least 8 correct answers. If you have 7 correct answers, you will receive 3.5 points, 6 correct answers for 3 points, 2 correct answer, you will receive 1 point. There is no deduction for wrong answers. You can attempt a quiz once only. Missed quizzes cannot be made up. I encourage you to write all the weekly quizzes.

The quizzes will be posted on Brightspace every Monday before 11:59 pm (except weeks 1, 4, 7, 9, 12) starting from the second week and students can complete each quiz any time before 8 pm of the lecture week. For example, the first quiz, based on Chapter and Lecture 1 & 2, will be posted on Brightspace on Monday (January 17) and you must finish your first quiz before 8 pm of January 19. This example applies to every quiz. More information is outlined in the weekly class schedule. Please ensure that you have a secure and reliable internet connection when completing the quizzes as they will be timed. Start your quiz after reading the weekly reading materials. Once the quiz is started online, students will have 20 minutes to complete the 8 quiz questions. They will be marked automatically, and students will receive their results through Brightspace.

#### **Mid-term Exam: [20%]: (Week 1-6)**

The mid-term exam will include multiple-choice and true-false questions. Students will be responsible for all the required readings and cases, as well as the material covered by the lectures. However, greater emphasis will be placed on materials covered in the first half (week 1 to 6) of the course. Further information will be provided later in the term. You are expected to answer 20 multiple-choice and true-false questions for this mid-term exam during a 30-minute window.

The mid-term exam will be held on March 02 during the class time between 3:00 pm and 3:30 pm.

### Assignment [20%]:

This assignment is designed to give students the chance to study a specific topic more deeply. The assignment topic will be posted on Brightspace.

Do NOT do additional research. Use ONLY course material to prepare your answers.

You <u>must</u> follow the University's policies on academic integrity. Answers must be your own original, individual work. Do not share or discuss answers with other students. Plagiarism is an academic offense. Please review the university policy regarding plagiarism (see link on page 9). To avoid plagiarism, use your own words (rather than quotations or lengthy paraphrasing) wherever possible. Doing so demonstrates that you understand the material and, also, tends to require fewer words. However, you must provide proper citations when relying on the ideas of others. Wherever you quote directly you must enclose the text in quotation marks ("-"), and include a footnote with the author's last name (in some cases, title of the readings accepted if you are unclear about the author) and page number of the text. You are requested not to use more than three quotations in this paper. Papers with too many direct quotes will lose marks as direct quotes do not count as your own work, no matter how carefully you have chosen the quote. Use any citation style of your choice but I prefer the *Canadian Guide to Uniform Legal Citation*, 9th ed (Toronto: Thomson Reuters, 2018). The length of the assignment should be between 1000-1200 words. The assignment is due on March 16 before 11:59 pm. Additional instructions for the assignment may be posted on Brightspace.

### Final Take-home Exam [30%]: [Week 7-12]

The final exam will be in essay format. You will be asked to answer two long questions during the examination period. Please note that the Final Exam in this course will be scheduled by Examination Services at a later date.

#### **Late Penalty**

Late submission will be penalized. Assignments submitted later than the due date will be penalized 5% per day of the total value of the assignment. For example, if an assignment worth 20% of the total course grade is a day late, 1 point out of 20 (or 5% per day) will be deducted. If you miss the final exam due to unavoidable circumstances such as illness and other compassionate grounds, please inform your course instructor as soon as possible.

#### **Extension**
