CALENDAR COURSE DESCRIPTION

The concepts employed by the law for creating and enforcing legal obligations between persons within society, including contract, tort, fiduciary obligation, and restitution. Consideration is given to the role of persons and the role of the state in ordering private legal obligations.

COURSE DESCRIPTION

This course is an introduction to private law relationships and examines the common law relating to contracts, torts (civil wrongs), trust law, and the interaction of private law relationships and public law (statute law passed by governments).

The course reviews concepts employed by the law for creating and enforcing legal obligations between persons within society, including contract, tort, fiduciary obligation and restitution. Consideration is given to the role of persons and the equitable and legal role of the state in ordering private legal obligations.
