# **Rapid Phone-Based Key Informant Interview**

# **Instructions to the interviewer**

This study intends to map out existing RLOs, regardless of their legal status, and to develop preliminary hypotheses on RLOs' response and perceived impact for Phase 2 of the study. These KIIs will consist of rapid semi-structured interviews over the phone. The interview will last a maximum of 30 minutes. All of these rapid interviews will take place over the phone, unless the participant requests an in-person meeting and it is safe to do so with the COVID-19 situation at the time of the interview.
