

## FGD with potential beneficiaries

### **Instructions to the interviewer**

FGDs will be used to allow people with similar backgrounds or experiences to discuss the perceived impact of the RLOs (RQ2) and factors that condition the response of RLOs (RQ3). In particular, participants will be asked about their perceptions of the response and impact of RLOs on their lives and their communities.

Potential beneficiaries refer to community members who fall under the stated mandate of RLOs selected for the study but who have not received services at the time of the study.

Each FGD will include five to eight participants, and they will take place in the local language that they feel the most comfortable speaking. The group composition will be carefully planned so as to not create an intimidating environment, so that participants feel free to talk openly and give honest opinions.

The table below explains the number of FGDs that will be conducted in each country and the number of participants. Criteria for selection of FGD participants will be developed based on the criteria for selection of RLOs that will be finalised at the end of Phase 1. At a minimum, researchers will set quotas for selection for FGD participants based on gender, nationality and age.

### **Introduction and background information on the study**
