Course description: A data-driven approach to statistical modeling. Basics of experimental design, analysis of variance, simple linear regression and correlation, nonparametric procedures. SAS will be the statistical software package used.

Prerequisites: STAT 2507 or STAT 2606 or STAT 3502; or permission of the School.

- <u>Simple Linear Regression:</u> Method of Least Squares, Inference, Analysis of Variance (ANOVA), Correlation, Test for Lack of Fit and Residual Analysis, Data Transformation.
- <u>Multiple Linear Regression:</u> Least Squares, Inference, ANOVA, Residual Analysis, Multicollinearity, Variable Selection Procedures.
- Experimental Design: Completely Randomized Design (CRD), Randomized Block Design (RBD), Multiple Comparisons, Non-parametric Tests.
- <u>Categorical Data:</u> Pearson's Chi-square Statistic; the Chi-square Test of Independence and Homogeneity.
