COURSE OUTLINE: PHIL 5600 Topics in History of Philosophy: Causation and Freedom in Early Modern Philosophy Winter 2024: Tuesdays, 11:35-14:25

Course description:

What are laws of nature? What is the relationship between science and metaphysics? In a lawgoverned world, is there any room for human freedom? What about a law-governed world created and conserved by a divine Being – can humans be free in such a world, and if so, in what sense? In this seminar we will look at early modern approaches to answering these and related questions about causation and freedom. We will be consulting primary texts from such philosophers as Descartes, Malebranche, Locke, Leibniz, and Shepherd, among others.

Required text:

There is no required text for this course.

We will be consulting a variety of primary texts. If you were an undergraduate at Carleton, you may have taken either PHIL 3002 (17th c Philosophy) or PHIL 3003 (18th c Philosophy); in this case, you will already own an anthology of early modern primary texts entitled "Modern Philosophy: An Anthology of Primary Sources," edited by Roger Ariew and Eric Watkins, published by Hackett. This text contains many (but not all) of the sources that we will be looking at. If you do not own this book, however, I will not require you to purchase it.

Because we will be consulting so many different primary sources, I will not require you to purchase any of them individually, either. Instead, I will make readings available on Brightspace, e.g. by linking to the library's e-resources (typically the "Past Masters" database), or through the ARES course reserves system.

Note: many of these primary texts are also available in full in various places online. However, some online sources are abridged or otherwise altered. If you wish to consult an online source other than the Past Masters database, you **must** discuss this with me, so that I can help you to evaluate whether or not the source is appropriate. Unless you consult with me, **you should not use outside online sources for any of your course assignments, including the final paper**.

Sometimes I may ask you to consult secondary sources. In particular, you will be asked to consult at least one secondary source when you give your presentation (see the section on evaluation, below.) Whenever I ask you to consult secondary sources, I will make those sources available on Brightspace, again, either through a link to the library's e-resources, or on ARES.

If you want to purchase the individual texts that we will be looking at, let me know, and I will send you references for the standard academic version of the texts. If you intend to do your graduate work (e.g. MA thesis or research paper work) in the history of philosophy, and especially in early modern philosophy, this may be a good idea for you (but it is not obligatory for this seminar.)

Technology requirements:

This course is an **in-person** course. The majority of the course will take place on campus, during regularly scheduled course hours. That said, some elements of the course require use of technology, including supplemental readings. I may also occasionally schedule Zoom class meetings or Zoom office hours, if needed. For these and other purposes, you will need access to a computer or some other device that allows you to reliably access the internet, with a camera and microphone for videoconferencing. If you anticipate having any problems with technology or internet access, please email me so that we can discuss possible solutions.

Brightspace:

This course will be supported by Brightspace. It is important for you to regularly check the Brightspace page for the course, which is where you will find (among other things) the most up-to-date information regarding our schedule of readings, which is open to revision throughout the semester.

Students are responsible for reading and responding appropriately to all information distributed through Brightspace. Information provided on Brightspace will be considered to have been provided to all registered students within 24 hours of posting.

Email:

You can email me using the email address at the top of the course outline, or through Brightspace. If you choose not to email me through Brightspace, then please be sure that your email is sent from your official Carleton email address. You should also check your Carleton email account regularly (alongside checking the Brightspace page), because when I send you emails, it will be to that email address. Please allow 24-48 hours for an email response; if I do not respond after 48 hours, please feel free to send me a gentle nudge.

Office hours:

Office hours this semester will be in person. You will find my office hours listed on the Brightspace page for the course. I am also available (and happy!) to meet virtually outside of office hours, by appointment; send me an email and we will work out a time.

Evaluation:

1. Participation (10%)

As graduate students, you are expected to come to class having read the material and being prepared to discuss it. Participation will be worth **10%** of your grade. Note: participation will be

judged by quality, not by quantity. I.e., it is not necessary that you constantly participate in class discussion, but in order to count towards the 10%, your comments should be relevant to the material or discussion at hand.

2. Presentation (40%)

You will be asked to present a topic to the class at least once during the semester. Presentations should be about 20-30 minutes long, including time for discussion, and typically will involve using a secondary source to provide a framework for discussion of a primary text. I will ask you to sign up for a presentation topic by the **end of the second week** of the semester (**Friday, Jan 19**) at the very latest.

For your presentation, you should produce either a detailed handout or a slideshow (on whatever software you feel comfortable using, as long as it's compatible with the classroom technology.) It's genuinely up to you to decide whether you would like to produce a handout or a slideshow; I have no preference. You should submit the handout or slideshow **on Brightspace before the beginning of class** on the day of your presentation. *Note*: if you decide to produce a handout, besides submitting it on Brightspace, please also email it to me, so that I can print copies to bring to class. (Or you can do this yourself, if you like – but let me know.)

You must meet with me virtually **at least one week before your presentation**, in order to discuss the presentation as well as the handout / slideshow.

Your presentation plus handout / slideshow will be worth **40%** of your final grade.

3. Final take-home exam (50%)

A mid-length paper (**12-18 pages**) on a topic of your choosing, due on the last day of exam period for the Winter Semester (**April 25, 2024**.) You must consult with me on your topic at least two weeks before final papers are due. *Topics must be approved*. This paper should be submitted on Brightspace (in .doc, .docx, or .pdf format) and will be worth **50%** of your grade. You are welcome to write your paper on the same topic as your presentation, if this is your preference, but you are not obligated to do so.

Academic Integrity Policy:

According to Carleton's Academic Integrity Policy, there are a number of activities that constitute violations of academic integrity, including plagiarism, collaborating on non-collaborative assignments, misrepresenting or falsifying your work, and more. For the purposes of this course, **this includes the use of computer applications or tools, such as artificial intelligence tools (AI)**; use of such tools will automatically be considered to be violations of academic integrity. I reserve the right to ask you to submit evidence of your work, including e.g. rough notes, drafts, or an explanation of the steps taken in completing the assignment. Assignments:

Please follow your professor's instructions on how assignments will be handled electronically. There will be NO hard copies placed in the essay box this coming year.

Evaluation:

Standing in a course is determined by the course instructor subject to the approval of the Faculty Dean. This means that grades submitted by the instructor may be subject to revision. No grades are final until they have been approved by the Dean.

Deferrals for Term Work:
