Myself and I

We will discuss myself and I. But, mainly, “myself” and “I”. Questions to be discussed will concern the nature of self-knowledge and what it means for a person to have a notion or concept of oneself. In so doing we will touch on issues pertaining to personal identity, self-reference, etc. And why/how the pronoun “I” plays a central role in these enterprises. We will also touch on questions pertaining to herself and “herself” and what is now known as *de se* beliefs. Authors to be read include Castañeda, Chisholm, Perry, and Lewis. We will also try to make some connections with the classical works of Descartes, Locke and Leibniz.

Examination

You’ll be assessed by:

- (i) one presentation in class and participation (30%);
- (ii) by a short essay due the first week (undergraduates 1000 words; MA students 1500 words) after reading week (30%);
- (iii) a final essay due the last day of class (undergraduates 1500-2000 words; MA students 2000-2500 words) (40%)

Assignments:

Unless specifically told otherwise by their instructors, students:

Jan. 6	Classes begin.
Jan. 17	Last day for registration and course changes in the winter term.
