GENEROSITY THAT'S OUT OF THIS WORLD

After retiring from Carleton in 1999 with an illustrious 31-year career, Dr. J.Y. Wong continues contributing to the university.

"During those years, I received excellent support from the university administration, at all levels, in research and teaching," explains the professor emeritus and adjunct research professor. "I thought that in return, it is time for me to contribute as much as I can to Carleton in the form of donations to establish undergraduate and graduate scholarships, and research and teaching facilities."

Wong spent his career in the Department of Mechanical and Aerospace Engineering, specializing in ground transportation technology. His research included off-road vehicle mobility, road vehicle dynamics, air cushion technology, and magnetic levitation systems. During his tenure, Wong organized a series of public lectures on "Overland transport technology and environment" presented by prominent experts from Canada, the US and UK, and professional development programs on "Terrain-vehicle systems analysis", which attracted professionals from many countries to attend. His work on computer simulation models to assess off-road vehicle mobility helped make Carleton a leader in this field of research.

It's probably not surprising then that one of Wong's first post-retirement gifts to Carleton was to establish the J.Y. Wong Laboratory for Terrestrial and Extraterrestrial Mobility, Guidance and Control in 2011. Researchers there have worked on everything from robotic arms to repair satellites in space to a mini-rover designed to collect scientific samples on the Moon, Mars, and beyond.

Recently, Wong and his wife made a gift to establish the J.Y. Wong and E.W. Wong Hub for Engineering and



Design Innovation. Located within the new Engineering and Design Centre, the Hub provides students with the resources to advance their innovative and creative capabilities. Previously, they established an undergraduate scholarship and a research award for Ph.D. candidates, both within mechanical and aerospace engineering. "I hope that these scholarships will encourage new generations of engineers to do their best to contribute a great deal to their field of specialization," Wong says.

Dr. and Mrs. Wong have also ensured that their legacy will continue after they are gone. A gift from their estates will establish a Prestigious Engineering Lecture Series. The series will bring world renowned experts to Carleton to provide students and faculty with information on the latest developments in the engineering field while also promoting the accomplishments of the Faculty of Engineering and Design to a larger audience.

"Carleton in many areas has done very good work, but people don't always realize it," he says. "So that is one of my motivations in donating to Carleton—to try to change that."

A UNIQUE SCHOLARSHIP FOR ZAMBIAN STUDENTS



Doug Anglin often said, "We make a living by what we earn, but we make a life by what we give", inspired by Winston Churchill's famous quote.

And true to his words, "giving" is exactly what the Anglin family did through the establishment of the Anglin Scholarship for Zambian Students to enhance the teaching and research capacity of the University of Zambia (UNZA). This unique example of inter-university cooperation enables and encourages students to pursue a Master's degree in any field of study at Carleton University, and then return to pursue a teaching career at UNZA. It was a natural outcome of Mary and Doug's long association with the people of Zambia, beginning when Doug served as the founding Vice-Chancellor of UNZA from 1965 to 1969. He was awarded an honorary doctorate by UNZA in 2011, in recognition of his contributions.

Doug's career path was influenced by his early years as a naval officer in World War II. He later taught political science and international affairs at Carleton from 1958 to 1989, with research interests focussing on peace, independence, and democracy in Africa. When in Ottawa, Mary and Doug provided a home away from home for many international students. In both their personal and professional lives, they dedicated themselves to human rights, racial justice, and equal educational opportunities for all.

Mary and Doug had the privilege of meeting the first two scholarship recipients, and two more Zambian students were awarded scholarships and completed their postgraduate studies at Carleton prior to Doug's death in 2021. These graduates reinforced the intent of the scholarship and serve as a source of inspiration for upcoming scholars at UNZA.

Support for future students is ensured by a generous bequest in the Anglin wills. Doug's legacy also includes the donation of his rich collection of records, articles, and other resources to the Institute of African Studies at Carleton. Mary and Doug Anglin's investment in the people and places that had a profound impact on their own lives will continue through the Anglin Scholarship for Zambian Students at Carleton University.

ESTATE PLANNING IS GOING DIGITAL: HOW TO GET A PLAN IN PLACE ONLINE

The core of a solid estate plan is a will, which outlines what happens when you pass away, and appoints key roles like an executor to wrap up your estate; a guardian for minor children and pets; and beneficiaries, whether individuals or charities, who will receive your assets. Traditionally, getting a will has been a very offline process: visit an estate lawyer in their office and get a paper document that must be signed and witnessed on paper. But estate planning has started to move online, making it easier, more affordable, and more convenient to check off your to-do list. Now there are platforms like my company Willful, which makes it easy, affordable, and convenient to create wills, power of attorney documents, and other estate planning documents online.

Legislation is also changing to support online processes - in 2021 British Columbia became the first province to allow electronic signatures and online storage of wills.

If you're considering creating your estate plan online, here are a few things to consider:

- Cost: Creating a will with an online platform can cost under \$100, whereas with a professional the average hourly rate for an estate lawyer in Canada is \$397. If cost is a factor, then an online platform can be much more friendly - and you can always upgrade to a lawyer-drafted will as your situation becomes more complex.
- Convenience: Many people choose online platforms because they can complete the process from home at their own leisure - this is especially helpful if you're on a deadline (for example traveling soon, or going in for surgery). Many lawyers do offer virtual meetings now, though many require document signing to happen in-person.
- Complexity of your situation: online platforms can be a great fit for Canadians with simple situations. If you have nuances due to business interests, foreign properties, or blended family considerations, you may be better suited to work with a professional, or to get the advice of a tax specialist.
- Advice: When using an online platform, you're essentially creating your own legal documents with guidance along the way; whereas when you visit a lawyer you're getting legal advice custom to your situation.

Knowing 57% of Canadian adults don't have a will, it's clear that the more we can move estate planning processes online, the more likely it is that we will prioritize these important tasks instead of putting them off for tomorrow.


Dear Donors,
