Making a Difference Award

Terms

Value \$5,000. Awarded on the recommendation of the Director of the Paul Menton Centre, to outstanding students with a documented permanent physical disability entering a program of study on a full-time basis within the Faculty of Engineering, the Faculty of Science, the Arthur Kroeger College of Public Affairs or the Bachelor of Commerce program. Recipients will demonstrate academic excellence, community service, leadership and commitment to making a difference in their larger communities. Application is required. Established in 2019 by Daryl Rock BA/86, MA/88.

This entrance award is to encourage high-achieving students to enroll in programs that set students up for success to be leaders of tomorrow and make a difference in their communities. Recipients will demonstrate academic excellence, community service, leadership and commitment to making a difference in their larger communities.

The award is valued at \$5000 in first year and renewable at \$5000 for second, third and fourth year (please refer to eligibility criteria below). The award may be continued for three consecutive years of undergraduate study provided the recipient maintains full-time enrolment (minimum of 4.0 credits over the Fall/Winter session) in an eligible undergraduate degree program and remains in good academic standing. If the award is lost in one year, it cannot be regained in subsequent years.

Eligibility

- Applicant must be a Canadian citizen or permanent resident of Canada (landed immigrant or protected person)
- Applicant must have a documented permanent physical disability
- Applicant must be admitted and enrolled full time (minimum of 4.0 credits over the Fall/Winter session) in an undergraduate degree program within the Faculty of Engineering, the Faculty of Science, the Arthur Kroeger College of Public Affairs or the Bachelor of Commerce program
- Applicant must be entering their first year of the program and pursuing post-secondary studies for the first time
- Applicant must demonstrate academic excellence
- Applicant must demonstrate community service, leadership activities and commitment to making a difference in their larger communities
