

## **Language Course Exemption**

The Political Science Language Requirement can be satisfied by demonstrating prior language proficiency in a language other than English. This form is to be used by students who wish to be exempted from taking language courses on the basis that they have prior proficiency. Please note that each individual application for an exemption from taking language courses will be treated on its merits. What are listed below are general guidelines that apply to the most common cases.

- 1. Students may present official documentation of language proficiency, including:
  - a. **Secondary school language of instruction:** Students whose secondary school transcripts show that their primary language of instruction in secondary school was a language other than English may be exempted from taking language courses.
  - French immersion: Students who have successfully completed Grade 12 French immersion or the equivalent at a Canadian high school may be exempted from taking language courses.
  - c. Other certification: Proficiency may be demonstrated through documentation of successful completion of recognized and certified language courses (e.g., certification from a recognized language testing authority, transfer credits from another university or college).
- 2. Students may undergo **testing** to demonstrate their language proficiency using one of the following options:
  - a. **French language examination:** The Department of Political Science conducts a French language exam twice a year, in November and February. Students who successfully complete this exam may be exempted from taking language courses. Note that Departmental language exams may not be repeated in case of failure.
  - b. Certificate from the School of Linguistics and Language Studies (SLALS) at Carleton:
    Students may demonstrate their proficiency in a language, other than French, that is
    taught at Carleton by obtaining a placement certificate from SLALS. The certificate is based
    on placement testing administered by SLALS. Students should complete the Language
    Background Questionnaire on the SLALS placemen testing website, and follow the
    instructions provided there for the Placement Test. Students must demonstrate
    competency at a level equivalent to or higher than the satisfactory completion of a
    beginner first-year course.
  - c. **For languages not taught at Carleton:** For languages not taught at Carleton, availability of a proficiency test depends upon faculty resource availability and is not guaranteed. Please complete the Language Exemption Form and submit your request to the Department.
